A BILL

- To amend the Balanced Budget and Emergency Deficit Control Act of 1985 to replace the sequester established by the Budget Control Act of 2011.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "National Security and
- 5 Job Protection Act".

6 SEC. 2. FINDINGS.

7 Congress finds the following:

 $\mathbf{2}$

1 (1) Current law requires that there be across-2 the-board cuts, known as a "sequester", imposed on January 2, 2013. The sequester will result in a 10 3 4 percent reduction in non-military personnel pro-5 grams of the Department of Defense and an 8 per-6 cent reduction in certain domestic programs, such as 7 the National Institutes of Health (NIH) and border security. 8

9 (2) Intended as a mechanism to force action,
10 there is bipartisan agreement that the sequester
11 going into place would undercut key responsibilities
12 of the Federal Government.

13 (3) As the Administration stated in its fiscal 14 vear 2013 budget request, "[Sequestration] would 15 lead to significant cuts to critical domestic programs 16 such as education and research and cuts to defense 17 programs that could undermine our national secu-18 rity. . . . [C]uts of this magnitude done in an 19 across-the-board fashion would be devastating both 20 to defense and non-defense programs." (The Budget 21 of the United States Government, Fiscal Year 2013, 22 p. 24, February 13, 2012).

(4) On March 29, 2012, The House of Representatives passed H. Con. Res. 112, the budget
resolution for fiscal year 2013, which includes rec-

onciliation instructions directing House Committees
 to craft legislation that would achieve the savings re quired to replace the sequestration called for in fis cal year 2013, as established by the Budget Control
 Act of 2011.

6 (5) On May 10, 2012, the House of Represent-7 atives passed H.R. 5652, the Sequestration Replace-8 ment Reconciliation Act of 2012, which would re-9 place the \$98 billion sequestration of discretionary 10 spending called for in 2013, as established by the 11 Budget Control Act of 2011, by making changes in 12 law to reduce direct spending by \$310 billion 13 through fiscal year 2022.

14 (6) An analysis of the impact of the sequestra-15 tion prepared for the Chairman of the House Armed 16 Services Committee found that if left in place, se-17 questration would cut the military to its smallest 18 size since before the Second World War, all while we 19 are still a nation at war in Afghanistan, facing in-20 creased threats from Iran and North Korea, unrest 21 in the Middle East, and a rising China.

1 (13) Beyond the negative impacts sequestration 2 will have on defense readiness, it will also undermine the industrial base needed to equip our armed forces 3 4 with the weapons and technology they need to com-5 plete their mission. A study released by the National 6 Association of Manufacturers suggests that 1.1 mil-7 lion workers in the supply chain could be adversely 8 affected, including 3.4 percent of workers in the 9 aerospace industry, 3.3 percent of the workforce in 10 the shipbuilding industry and 10 percent of the 11 workers in the search and navigation equipment in-12 dustry.

13 SEC. 3. CONDITIONAL REPLACEMENT FOR FY 2013 SEQUES14 TER.

(a) CONTINGENT EFFECTIVE DATE.—This section
and the amendments made by it shall take effect upon
the enactment of—

(1) the Act contemplated in section 201 of H.
Con. Res. 112 (112th Congress) that achieves at
least the deficit reduction called for in such section
for such periods; or

(2) similar legislation that achieves outlay reductions within five years after the date of enactment that equal or exceed the outlay reductions
flowing from the budget authority reductions man-

9 SEC. 4. PRESIDENTIAL SUBMISSION.

10 Not later than October 15, 2012, the President shall
11 transmit to Congress a legislative proposal that meets the
12 requirements of section 3(a)(2) of this Act.
