- 8 (a) IN GENERAL.—The Secretary of Homeland Secu-
- 9 rity shall submit to the Committee on Homeland Security
- 10 of the House of Representatives and the Committee on
- 11 Homeland Security and Governmental Affairs of the Sen-
- 12 ate, as part of the Department of Homeland Security's
- 13 Annual Performance Report, an annual report on the
- 14 number of miles of the international land and maritime
- 15 border between the United States and Canada and the
