## A BILL

To amend title 38, United States Code, to provide for annual cost-of-living adjustments to be made automatically by law each year in the rates of disability compensation for veterans with service-connected disabilities and the rates of dependency and indemnity compensation for survivors of certain service-connected disabled veterans.

## 1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "American Heroes
- 3 COLA Act".
- 4 SEC. 2. AUTOMATIC ANNUAL INCREASE IN RATES OF DIS-
- 5 ABILITY COMPENSATION AND DEPENDENCY
- 6 AND INDEMNITY COMPENSATION.
- 7 (a) Indexing to Social Security Increases.—
- 8 Section 5312 of title 38, United States Code, is amended
- 9 by adding at the end the following new subsection:
- " (d)(1) Whenever there is an increase in benefit
- 11 amounts payable under title II of the Social Security Act
- 12 (42 U.S.C. 401 et seq.) as a result of a determination
- 13 made under section 215(i) of such Act (42 U.S.C. 415(i)),
- 14 the Secretary shall, effective on the date of such increase
- 15 in benefit amounts, increase the dollar amounts in effect
- 16 for the payment of disability compensation and depend-
- 17 ency and indemnity compensation by the Secretary, as
- 18 specified in paragraph (2), as such amounts were in effect
- 19 immediately before the date of such increase in benefit
- 20 amounts payable under title II of the Social Security Act,
- 21 by the same percentage as the percentage by which such
- 22 benefit amounts are increased, but only if such percentage
- 23 increase is calculated using the Bureau of Labor Statistics
- 24 Consumer Price Index for Urban Wage Earners and Cler-
- 25 ical Workers.

3	"(4) During the period beginning on the date of the
4	enactment of this subsection and ending on September 30,
5	2018, each dollar amount increased under paragraph (1),
6	if not a whole dollar amount, shall be rounded to the next
7	lower whole dollar amount.
8	"(5) The Secretary of Veterans Affairs may adjust
9	administratively, consistent with the increases made under
10	subsection (a), the rates of disability compensation pay-
11	able to persons under section 10 of Public Law 85–857
12	(72 Stat. 1263) who have not received compensation
13	under chapter 11 of this title.".
14	(b) Effective Date.—Subsection (d) of section

18	SEC. 3. INCREASE IN RATE OF SPECIAL MONTHLY COM-
19	PENSATION FOR SEVERELY INJURED VET-
20	ERANS.
21	(a) Increase.—
22	(1) In general.—Section 1114(r) of title 38,
23	United States Code, is amended—
24	(A) in paragraph (1), by striking "\$2,002"
25	and inserting "\$3,163"; and

1	(B) in paragraph (2), by striking "\$2,983"
2	and inserting "\$4,713".
3	(2) Effective date.—The amendments made
4	by paragraph (1) shall take effect on December 1,
5	2014.
6	(b) Temporary Rates.—During the period begin-
7	ning on December 1, 2014, and ending on September 30,
8	2018, section 1114(r) of title 38, United States Code, as
9	amended by subsection (a), shall be applied—
10	(1) in paragraph (1), by substituting "\$2,742"
11	for "\$3,163"; and
12	(2) in paragraph (2), by substituting "\$4085"
13	for "\$4,713".
