A BILL

To amend title 38, United States Code, to improve the accountability of the Secretary of Veterans Affairs to the Inspector General of the Department of Veterans Affairs.

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Demanding Account-
- 5 ability for Veterans Act of 2014".

1 SEC. 2. SCORING OF BUDGETARY EFFECTS.

- 2 The budgetary effects of this Act, for the purpose of
- 3 complying with the Statutory Pay-As-You-Go Act of 2010,
- 4 shall be determined by reference to the latest statement

10	addition to any responsibility or authority provided to the
11	Inspector General in the Inspector General Act of 1978

15	spect to a responsible manager, an issue described in
16	a covered report for which the manager is or was re-
17	sponsible.
18	"(2) The term 'covered report' means a report
19	by the Inspector General of the Department of Vet-
20	erans Affairs that recommends actions to the Sec-
21	retary of Veterans Affairs (or other official or em-
22	ployee of the Department) to address an issue in the
23	Department with respect to public health or safety.
