## A BILL

To simplify and streamline the information regarding institutions of higher education made publicly available by the Secretary of Education, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Strengthening Trans-  
5 parency in Higher Education Act”.

1 **SEC. 2. COLLEGE DASHBOARD WEBSITE.**

2 (a) ESTABLISHMENT.—Section 132 of the Higher  
3 Education Act of 1965 (20 U.S.C. 1015a) is amended—

4 (1) in subsection (a)—

5 (A) in paragraph (2), by striking “first-  
6 time,”;

7 (B) in paragraph (3) in the matter pre-  
8 ceding subparagraph (A), by striking “first-  
9 time,”; and

10 (C) in paragraph (4), by striking “first-  
11 time,”;

12 (2) in subsection (b)—

13 (A) in paragraph (1), by striking “first-  
14 time”; and

15 (B) in paragraph (2), by striking “first-  
16 time”;

17 (3) by striking subsections (c) through (g), (j),  
18 and (l);

19 (4) by redesignating subsections (h), (i), and  
20 (k) as subsections (c), (d), and (e), respectively; and

21 (5) by striking subsection (d) (as so redesign-  
22 ated) and inserting the following new subsection:

23 “(d) CONSUMER INFORMATION.—

24 “(1) AVAILABILITY OF TITLE IV INSTITUTION  
25 INFORMATION.—The Secretary shall develop and  
26 make publicly available a website to be known as the

1       ‘College Dashboard website’ in accordance with this  
2       section and prominently display on such website, in  
3       simple, understandable, and unbiased terms for the  
4       most recent academic year for which satisfactory  
5       data are available, the following information with re-  
6       spect to each institution of higher education that  
7       participates in a program under title IV:

8               “(A) A link to the website of the institu-  
9       tion.

10              “(B) An identification of the type of insti-  
11       tution as one of the following:

12                   “(i) A four-year public institution of  
13       higher education.

14                   “(ii) A four-year private, nonprofit in-  
15       stitution of higher education.

16                   “(iii) A four-year private, for-profit  
17       institution of higher education.

18                   “(iv) A two-year public institution of  
19       higher education.

20                   “(v) A two-year private, nonprofit in-  
21       stitution of higher education.

22                   “(vi) A two-year private, for-profit in-  
23       stitution of higher education.

24                   “(vii) A less than two-year public in-  
25       stitution of higher education.

1                   “(viii) A less than two-year private,  
2                   nonprofit institution of higher education.

3                   “(ix) A less than two-year private,  
4                   for-profit institution of higher education.

5                   “(C) The number of students enrolled at  
6                   the institution—

7                   “(i) as undergraduate students; and

8                   “(ii) as graduate students, if applica-  
9                   ble.

10                  “(D) The student-faculty ratio.

11                  “(E) The percentage of degree-seeking or  
12                  certificate-seeking undergraduate students en-  
13                  rolled at the institution who obtain a degree or  
14                  certificate within—

15                  “(i) 100 percent of the normal time  
16                  for completion of, or graduation from, the  
17                  program in which the student is enrolled;

18                  “(ii) 150 percent of the normal time  
19                  for completion of, or graduation from, the  
20                  program in which the student is enrolled;  
21                  and

22                  “(iii) 200 percent of the normal time  
23                  for completion of, or graduation from, the  
24                  program in which the student is enrolled.

1           “(F) The average net price per year for  
2 undergraduate students receiving Federal stu-  
3 dent financial aid under title IV based on an in-  
4 come category selected by the user from a list  
5 containing the following income categories:

6           “(i) \$0 to \$30,000.

7           “(ii) \$30,001 to \$48,000.

8           “(iii) \$48,001 to \$75,000.

9           “(iv) \$75,001 to \$110,000.

10          “(v) \$110, 001 to \$150,000.

11          “(vi) Over \$150,000.

12          “(G) A link to the net price calculator for  
13 such institution.

14          “(H) The percentage of undergraduate  
15 students who obtained a certificate or degree  
16 from the institution who borrowed Federal stu-  
17 dent loans and the average Federal student  
18 loan debt incurred by an undergraduate student  
19 who obtained a certificate or degree from the  
20 institution and borrowed Federal student loans  
21 in the course of obtaining such certificate or de-  
22 gree.

23          “(I) A link to national and regional data  
24 from the Bureau of Labor Statistics on starting  
25 salaries in all major occupations.

1           “(J) A link to the webpage of the institu-  
2           tion containing campus safety data with respect  
3           to such institution.

4           “(2) ADDITIONAL INFORMATION.—The Sec-  
5           retary shall publish on Internet webpages that are  
6           linked to through the College Dashboard website for  
7           the most recent academic year for which satisfactory  
8           data is available the following information with re-  
9           spect to each institution of higher education that  
10          participates in a program under title IV:

11           “(A) ENROLLMENT.—

12           “(i) The percentages of male and fe-  
13           male undergraduate students enrolled at  
14           the institution.

15           “(ii) The percentages of under-  
16           graduate students enrolled at the institu-  
17           tion—

18           “(I) full-time; and

19           “(II) less than full-time.

20           “(iii) In the case of an institution  
21           other than an institution that provides all  
22           courses and programs through distance  
23           education, of the undergraduate students  
24           enrolled at the institution—

1                   “(I) the percentage of such stu-  
2                   dents who are from the State in which  
3                   the institution is located;

4                   “(II) the percentage of such stu-  
5                   dents who are from other States; and

6                   “(III) the percentage of such stu-  
7                   dents who are international students.

8                   “(iv) The percentages of under-  
9                   graduate students enrolled at the institu-  
10                  tion, disaggregated by—

11                   “(I) race and ethnic background;

12                   “(II) classification as a student  
13                   with a disability;

14                   “(III) recipients of a Federal Pell  
15                   Grant;

16                   “(IV) recipients of assistance  
17                   under a tuition assistance program  
18                   conducted by the Department of De-  
19                   fense under section 1784a or 2007 of  
20                   title 10, United States Code, or other  
21                   authorities available to the Depart-  
22                   ment of Defense or veterans’ edu-  
23                   cation benefits (as defined in section  
24                   480); and

1                   “(V) recipients of a Federal stu-  
2                   dent loan.

3                   “(B) COMPLETION.—The information re-  
4                   quired under paragraph (1)(E), disaggregated  
5                   by—

6                   “(i) recipients of a Federal Pell  
7                   Grant;

8                   “(ii) recipients of a loan made under  
9                   part D (other than a Federal Direct Un-  
10                  subsidized Stafford Loan) who did not re-  
11                  ceive a Federal Pell Grant;

12                  “(iii) persons who did not receive a  
13                  Federal Pell Grant or a loan made under  
14                  part D (other than a Federal Direct Un-  
15                  subsidized Stafford Loan);

16                  “(iv) race and ethnic background;

17                  “(v) classification as a student with a  
18                  disability; and

19                  “(vi) recipients of assistance under a  
20                  tuition assistance program conducted by  
21                  the Department of Defense under section  
22                  1784a or 2007 of title 10, United States  
23                  Code, or other authorities available to the  
24                  Department of Defense or veterans’ edu-  
25                  cation benefits (as defined in section 480).

1 “(C) COSTS.—

2 “(i) The cost of attendance for full-  
3 time undergraduate students enrolled in  
4 the institution who live on campus.

5 “(ii) The cost of attendance for full-  
6 time undergraduate students enrolled in  
7 the institution who live off campus.

8 “(iii) The cost of tuition and fees for  
9 full-time undergraduate students enrolled  
10 in the institution.

11 “(iv) The cost of tuition and fees per  
12 credit hour or credit hour equivalency for  
13 undergraduate students enrolled in the in-  
14 stitution less than full time.

15 “(v) In the case of a public institution  
16 of higher education (other than an institu-  
17 tion described in clause (vi)) and notwith-  
18 standing subsection (b)(1), the costs de-  
19 scribed in clauses (i) and (ii) for—

20 “(I) full-time students enrolled in  
21 the institution who are residents of  
22 the State in which the institution is  
23 located; and

1                   “(II) full-time students enrolled  
2                   in the institution who are not resi-  
3                   dents of such State.

4                   “(vi) In the case of a public institu-  
5                   tion of higher education that offers dif-  
6                   ferent tuition rates for students who are  
7                   residents of a geographic subdivision small-  
8                   er than a State and students not located in  
9                   such geographic subdivision and notwith-  
10                  standing subsection (b)(1), the costs de-  
11                  scribed in clauses (i) and (ii) for—

12                  “(I) full-time students enrolled at  
13                  the institution who are residents of  
14                  such geographic subdivision;

15                  “(II) full-time students enrolled  
16                  at the institution who are residents of  
17                  the State in which the institution is  
18                  located but not residents of such geo-  
19                  graphic subdivision; and

20                  “(III) full-time students enrolled  
21                  at the institution who are not resi-  
22                  dents of such State.

23                  “(D) FINANCIAL AID.—

24                  “(i) The average annual grant amount  
25                  (including Federal, State, and institutional

1 aid) awarded to an undergraduate student  
2 enrolled at the institution who receives fi-  
3 nancial aid.

4 “(ii) The percentage of undergraduate  
5 students enrolled at the institution receiv-  
6 ing Federal, State, and institutional  
7 grants, student loans, and any other type  
8 of student financial assistance known by  
9 the institution, provided publicly or  
10 through the institution, such as Federal  
11 work-study funds.

12 “(iii) The cohort default rate (as de-  
13 fined in section 435(m)) for such institu-  
14 tion.

15 “(E) FACULTY INFORMATION.—

16 “(i) The ratio of the number of course  
17 sections taught by part-time instructors to  
18 the number of course sections taught by  
19 full-time faculty, disaggregated by course  
20 sections intended primarily for under-  
21 graduate students and course sections in-  
22 tended primarily for graduate students.

23 “(ii) The mean and median years of  
24 employment for part-time instructors.

25 “(3) OTHER DATA MATTERS.—

1           “(A) COMPLETION DATA.—The Commis-  
2           sioner of Education Statistics shall ensure that  
3           the information required under paragraph  
4           (1)(E) includes information with respect to all  
5           students at an institution, including students  
6           other than first-time, full-time students and  
7           students who transfer to another institution, in  
8           a manner that the Commissioner considers ap-  
9           propriate.

10           “(B) ADJUSTMENT OF INCOME CAT-  
11           EGORIES.—The Secretary may annually adjust  
12           the range of each of the income categories de-  
13           scribed in paragraph (1)(F) to account for a  
14           change in the Consumer Price Index for All  
15           Urban Consumers as determined by the Bureau  
16           of Labor Statistics if the Secretary determines  
17           an adjustment is necessary.

18           “(4) INSTITUTIONAL COMPARISON.—The Sec-  
19           retary shall include on the College Dashboard  
20           website a method for users to easily compare the in-  
21           formation required under paragraphs (1) and (2) be-  
22           tween institutions.

23           “(5) UPDATES.—

1           “(A) DATA.—The Secretary shall update  
2 the College Dashboard website not less than an-  
3 nually.

4           “(B) TECHNOLOGY AND FORMAT.—The  
5 Secretary shall regularly assess the format and  
6 technology of the College Dashboard website  
7 and make any changes or updates that the Sec-  
8 retary considers appropriate.

9           “(6) CONSUMER TESTING.—

10           “(A) IN GENERAL.—In developing and  
11 maintaining the College Dashboard website, the  
12 Secretary, in consultation with appropriate de-  
13 partments and agencies of the Federal Govern-  
14 ment, shall conduct consumer testing with ap-  
15 propriate persons, including current and pro-  
16 spective college students, family members of  
17 such students, institutions of higher education,  
18 and experts, to ensure that the College Dash-  
19 board website is usable and easily understand-  
20 able and provides useful and relevant informa-  
21 tion to students and families.

22           “(B) RECOMMENDATIONS FOR  
23 CHANGES.—The Secretary shall submit to the  
24 authorizing committees any recommendations  
25 that the Secretary considers appropriate for

1 changing the information required to be pro-  
2 vided on the College Dashboard website under  
3 paragraphs (1) and (2) based on the results of  
4 the consumer testing conducted under subpara-  
5 graph (A).

6 “(7) PROVISION OF APPROPRIATE LINKS TO  
7 PROSPECTIVE STUDENTS AFTER SUBMISSION OF  
8 FAFSA.—The Secretary shall provide to each stu-  
9 dent that submits a Free Application for Federal  
10 Student Aid described in section 483 a link to the  
11 webpage of the College Dashboard website that con-  
12 tains the information required under paragraph (1)  
13 for each institution of higher education such student  
14 includes on such Application.

15 “(8) INTERAGENCY COORDINATION.—The Sec-  
16 retary, in consultation with each appropriate head of  
17 a department or agency of the Federal Government,  
18 shall ensure to the greatest extent practicable that  
19 any information related to higher education that is  
20 published by such department or agency is con-  
21 sistent with the information published on the College  
22 Dashboard website.

23 “(9) REFERENCES TO COLLEGE NAVIGATOR  
24 WEBSITE.—Any reference in this Act to the College

1 Navigator website shall be considered a reference to  
2 the College Dashboard website.”.

3 (b) CONFORMING AMENDMENTS.—The Higher Edu-  
4 cation Act of 1965 (20 U.S.C. 1001 et seq.), as amended  
5 by subsection (a) of this section, is further amended—

6 (1) in section 131(h) (20 U.S.C. 1015(h)), by  
7 striking “College Navigator” and inserting “College  
8 Dashboard”; and

9 (2) in section 132(a) (20 U.S.C. 1015a(a)), by  
10 striking paragraph (1) and inserting the following  
11 new paragraph:

12 “(1) COLLEGE DASHBOARD WEBSITE.—The  
13 term ‘College Dashboard website’ means the College  
14 Dashboard website required under subsection (d).”.

15 (c) DEVELOPMENT.—The Secretary of Education  
16 shall develop and publish the College Dashboard website  
17 required under section 132 of the Higher Education Act  
18 of 1965 (20 U.S.C. 1015a), as amended by subsections  
19 (a) and (b) of this section, not later than one year after  
20 the date of the enactment of this Act.

21 (d) COLLEGE NAVIGATOR WEBSITE MAINTENANCE.—The Secretary shall maintain the College Navi-  
22 gator website required under section 132 of the Higher  
23 Education Act of 1965 (20 U.S.C. 1015a), as in effect  
24 the day before the date of the enactment of this Act, in  
25

1 the manner required under the Higher Education Act of  
2 1965, as in effect on such day, until the College Dash-  
3 board website referred to in subsection (c) is complete and  
4 publicly available on the Internet.

5 **SEC. 3. NET PRICE CALCULATORS.**

6 Subsection (c) of section 132 of the Higher Edu-  
7 cation Act of 1965 (20 U.S.C. 1015a), as redesignated  
8 by section 2(a)(4) of this Act, is amended—

9 (1) by redesignating paragraph (4) as para-  
10 graph (6); and

11 (2) by inserting after paragraph (3) the fol-  
12 lowing new paragraphs:

13 “(4) **MINIMUM REQUIREMENTS FOR NET PRICE**  
14 **CALCULATORS.**—Not later than 1 year after the date  
15 of the enactment of the Strengthening Transparency  
16 in Higher Education Act, a net price calculator for  
17 an institution of higher education shall meet the fol-  
18 lowing requirements:

19 “(A) The link for the calculator shall—

20 “(i) be clearly labeled as a net price  
21 calculator and prominently, clearly, and  
22 conspicuously posted in locations on the  
23 website of such institution where informa-  
24 tion on costs and aid is provided and any

1 other location that the institution considers  
2 appropriate; and

3 “(ii) match in size and font to the  
4 other prominent links on the webpage  
5 where the link for the calculator is dis-  
6 played.

7 “(B) The webpage displaying the results  
8 for the calculator shall specify at least the fol-  
9 lowing information:

10 “(i) The net price (as calculated  
11 under subsection (a)(2)) for such institu-  
12 tion, which shall be the most visually  
13 prominent figure on the results screen.

14 “(ii) Cost of attendance, including—

15 “(I) tuition and fees;

16 “(II) average annual cost of  
17 room and board for the institution for  
18 a full-time undergraduate student en-  
19 rolled in the institution;

20 “(III) average annual cost of  
21 books and supplies for a full-time un-  
22 dergraduate student enrolled in the  
23 institution; and

24 “(IV) estimated cost of other ex-  
25 penses (including personal expenses

1 and transportation) for a full-time un-  
2 dergraduate student enrolled in the  
3 institution.

4 “(iii) Estimated total need-based  
5 grant aid and merit-based grant aid from  
6 Federal, State, and institutional sources  
7 that may be available to a full-time under-  
8 graduate student.

9 “(iv) Percentage of the full-time un-  
10 dergraduate students enrolled in the insti-  
11 tution that received any type of grant aid  
12 described in clause (iii).

13 “(v) The disclaimer described in para-  
14 graph (6).

15 “(vi) In the case of a calculator  
16 that—

17 “(I) includes questions to esti-  
18 mate the eligibility of a student or  
19 prospective student for veterans’ edu-  
20 cation benefits (as defined in section  
21 480) or educational benefits for active  
22 duty service members, such benefits  
23 are displayed on the results screen in  
24 a manner that clearly distinguishes

1 such benefits from the grant aid de-  
2 scribed in clause (iii); or

3 “(II) does not include questions  
4 to estimate eligibility for the benefits  
5 described in subclause (I), the results  
6 screen indicates that certain students  
7 (or prospective students) may qualify  
8 for such benefits and includes a link  
9 to information about such benefits.

10 “(C) The institution shall populate the cal-  
11 culator with data from an academic year that  
12 is not more than 2 academic years prior to the  
13 most recent academic year.

14 “(5) PROHIBITION ON USE OF DATA COL-  
15 LECTED BY THE NET PRICE CALCULATOR.—A net  
16 price calculator for an institution of higher edu-  
17 cation shall—

18 “(A) clearly indicate which questions are  
19 required to be completed for an estimate of the  
20 net price from the calculator;

21 “(B) in the case of a calculator that re-  
22 quests contact information from users, clearly  
23 mark such requests as optional and provide for  
24 an estimate of the net price from the calculator

1 without requiring users to enter such informa-  
2 tion; and

3 “(C) prohibit any personally identifiable in-  
4 formation provided by users from being sold or  
5 made available to third parties.”.

6 **SEC. 4. FUNDING.**

7 (a) **USE OF EXISTING FUNDS.**—Of the amount au-  
8 thorized to be appropriated to the Department of Edu-  
9 cation to maintain the College Navigator website,  
10 \$1,000,000 shall be available to carry out this Act and  
11 the amendments made by this Act.

12 (b) **NO ADDITIONAL FUNDS AUTHORIZED.**—No  
13 funds are authorized by this Act to be appropriated to  
14 carry out this Act or the amendments made by this Act.
