A BILL

To establish the Virgin Islands of the United States
Centennial Commission.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Virgin Islands of the*
5 *United States Centennial Commission Act”.*

6 **SEC. 2. ESTABLISHMENT.**

7 *There is established a commission to be known as the*
8 *“Virgin Islands of the United States Centennial Commis-*
9 *sion” (in this Act referred to as the “Commission”).*

10 **SEC. 3. DUTIES OF COMMISSION.**

11 *The Commission shall—*

12 *(1) plan, develop, and carry out such activities*
13 *as the Commission determines to be appropriate to*
14 *commemorate the 100th anniversary of the Virgin Is-*
15 *lands of the United States becoming an unincor-*
16 *porated territory of the United States;*

17 *(2) provide advice and assistance to Federal,*
18 *State, and local governmental agencies, as well as*
19 *civic groups to carry out activities to commemorate*
20 *the 100th anniversary of the Virgin Islands of the*
21 *United States becoming an unincorporated territory*
22 *of the United States; and*

23 *(3) submit to the President and Congress the re-*
24 *ports required pursuant to section 7.*

1 **SEC. 4. MEMBERSHIP.**

2 (a) *NUMBER AND APPOINTMENT.*—*The Commission*
3 *shall be composed of 8 members as follows:*

4 (1) *The Assistant Secretary of the Interior for*
5 *Insular Affairs or a designee of the Assistant Sec-*
6 *retary.*

7 (2) *One member appointed by the Governor of*
8 *the Virgin Islands of the United States or a designee*
9 *of the Governor.*

10 (3) *Two Members of the House of Representatives*
11 *appointed by the Speaker of the House of Representa-*
12 *tives.*

13 (4) *One Member of the House of Representatives*
14 *appointed by the minority leader of the House of Rep-*
15 *resentatives.*

16 (5) *Two Members of the Senate appointed by the*
17 *majority leader of the Senate.*

18 (6) *One Member of the Senate appointed by the*
19 *minority leader of the Senate.*

20 (b) *TERMS.*—*Each member of the Commission shall be*
21 *appointed for the life of the Commission.*

22 (c) *DEADLINE FOR APPOINTMENT.*—*All members of the*
23 *Commission shall be appointed not later than 90 days after*
24 *the date of the enactment of this Act.*

25 (d) *VACANCIES.*—*A vacancy on the Commission*
26 *shall—*

1 (1) *not affect the powers of the Commission; and*

2 (2) *be filled in the manner in which the original*
3 *appointment was made.*

4 (e) *RATES OF PAY.—Members shall not receive com-*
5 *ensation for the performance of duties on behalf of the*
6 *Commission.*

7 (f) *TRAVEL EXPENSES.—Each member of the Commis-*
8 *sion shall be reimbursed for travel and per diem in lieu*
9 *of subsistence expenses during the performance of duties of*
10 *the Commission while away from home or regular place of*
11 *business of the member, in accordance with applicable pro-*
12 *visions under subchapter I of chapter 57 of title 5, United*
13 *States Code.*

14 (g) *QUORUM.—A majority of the members of the Com-*
15 *mission shall constitute a quorum to conduct business, but*
16 *two or more members may hold hearings.*

17 (h) *CHAIRPERSON.—The chairperson of the Commis-*
18 *sion shall be selected by a majority vote of the members of*
19 *the Commission.*

20 **SEC. 5. DIRECTOR AND STAFF OF COMMISSION.**

21 (a) *DIRECTOR AND STAFF.—The Commission shall ap-*
22 *point an executive director and such other additional per-*
23 *sonnel as are necessary to enable the Commission to perform*
24 *the duties of the Commission.*

1 (b) *APPLICABILITY OF CERTAIN CIVIL SERVICE*
2 *LAWS.*—*The executive director and staff of the Commission*
3 *may be appointed without regard to the provisions of title*
4 *5, United States Code, governing appointments in the com-*
5 *petitive service, and may be paid without regard to the pro-*
6 *visions of chapter 51 and subchapter III of chapter 53 of*
7 *such title relating to classification and General Schedule*
8 *pay rates, except that the rate of pay for the executive direc-*
9 *tor and other staff may not exceed the rate payable for level*
10 *III of the Executive Schedule under section 5314 of such*
11 *title.*

12 (c) *DETAIL OF FEDERAL EMPLOYEES.*—*Upon request*
13 *of the Commission, the Secretary of the Interior or the Ar-*
14 *chivist of the United States may detail, on a reimbursable*
15 *basis, any of the personnel of the Department of the Interior*
16 *or the National Archives and Records Administration, re-*
17 *spectively to the Commission to assist the Commission to*
18 *perform the duties of the Commission.*

19 (d) *EXPERTS AND CONSULTANTS.*—*The Commission*
20 *may procure such temporary and intermittent services from*
21 *experts and consultants as are necessary to enable the Com-*
22 *mission to perform the duties of the Commission.*

23 (e) *VOLUNTEER AND UNCOMPENSATED SERVICES.*—
24 *Notwithstanding section 1342 of title 31, United States*
25 *Code, the Commission may accept and use voluntary and*

1 *uncompensated services as the Commission determines nec-*
2 *essary.*

3 **SEC. 6. POWERS OF COMMISSION.**

4 (a) *HEARINGS.*—*The Commission may, for the pur-*
5 *pose of carrying out this Act, hold hearings, sit and act*
6 *at times and places, take testimony, and receive evidence*
7 *as the Commission considers appropriate.*

8 (b) *MAILS.*—*The Commission may use the United*
9 *States mails in the same manner and under the same condi-*
10 *tions as other Federal agencies.*

11 (c) *OBTAINING OFFICIAL DATA.*—*The Commission*
12 *may secure directly from any Federal agency information*
13 *necessary to enable the Commission to perform the duties*
14 *of the Commission. Upon request of the chairperson of the*
15 *Commission, the head of that Federal agency shall furnish*
16 *that information to the Commission.*

17 (d) *GIFTS, BEQUESTS, DEVISES.*—*The Commission*
18 *may solicit, accept, use, and dispose of gifts, bequests, or*
19 *devises of money, services, or property, both real and per-*
20 *sonal, for the purpose of aiding or facilitating the work of*
21 *the Commission.*

22 (e) *AVAILABLE SPACE.*—*Upon the request of the Com-*
23 *mission, the Administrator of General Services shall make*
24 *available to the Commission, at a normal rental rate for*
25 *Federal agencies, such assistance and facilities as may be*

1 *necessary for the Commission to perform the duties of the*
2 *Commission.*

3 (f) *CONTRACT AUTHORITY.*—*The Commission may*
4 *enter into contracts with and compensate the Federal Gov-*
5 *ernment, State and local governments, private entities, or*
6 *individuals to enable the Commission to perform the duties*
7 *of the Commission.*

8 **SEC. 7. REPORTS.**

9 (a) *ANNUAL REPORTS.*—*Not later than January 31 of*
10 *each year, and annually thereafter until the final report*
11 *is submitted pursuant to subsection (b), the Commission*
12 *shall submit to the President and the Congress a report*
13 *on—*

14 (1) *the activities of the Commission; and*
15 (2) *the revenue and expenditures of the Commis-*
16 *sion, including a list of each gift, bequest, or devise*
17 *to the Commission with a value of more than \$250,*
18 *including the identity of the donor of each gift, be-*
19 *quest, or devise.*

20 (b) *FINAL REPORT.*—*Not later than January 31,*
21 *2018, the Commission shall submit a final report to the*
22 *President and the Congress containing—*

23 (1) *a summary of the activities of the Commis-*
24 *sion; and*

1 (2) *a final accounting of funds received and ex-*
2 *pended by the Commission.*

3 **SEC. 8. ANNUAL AUDIT.**

4 *The Inspector General of the Department of the Inte-*
5 *rior—*

6 (1) *may perform an audit of the Commission;*

7 (2) *shall make the results of any such audit*
8 *available to the public; and*

9 (3) *shall transmit such results to the Committee*
10 *on Oversight and Government Reform of the House of*
11 *Representatives and the Committee on Homeland Se-*
12 *curity and Governmental Affairs of the Senate.*

13 **SEC. 9. DEFINITIONS.**

14 *In this Act:*

15 (1) *FEDERAL AGENCY.—The term “Federal agen-*
16 *cy” has the meaning given the term “agency” in sec-*
17 *tion 551 of title 5, United States Code.*

18 (2) *STATE.—The term “State” means each of the*
19 *several States, the District of Columbia, each territory*
20 *or possession of the United States, and each federally*
21 *recognized Indian tribe.*

22 **SEC. 10. TERMINATION.**

23 *The Commission shall terminate on September 30,*
24 *2018, or may terminate at an earlier date determined by*

1 *the Commission after the final report is submitted pursuant*
2 *to section 7(b).*

3 **SEC. 11. NO ADDITIONAL FUNDS AUTHORIZED.**

4 *No Federal funds are authorized or may be obligated*
5 *to carry out this Act.*
