### **3** SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Fallen Heroes Flag
- 5 Act of 2016".

### 6 SEC. 2. DEFINITIONS.

7 In this Act—

1	(1) the term "Capitol-flown flag" means a flag
2	of the United States flown over the Capitol in honor
3	of the deceased individual for whom the flag is re-
4	quested;
5	(2) the terms "chaplain", "firefighter", "law
6	enforcement officer", "member of a rescue squad or
7	ambulance crew", and "public agency" have the
8	meanings given such terms in section 1204 of the
9	Omnibus Crime Control and Safe Streets Act of
10	1968 (42 U.S.C. 3796b);
11	(3) the term "immediate family member", with
12	respect to an individual, means—
13	(A) the spouse, parent, brother, sister, or
14	child of the individual or a person to whom the
15	individual stands in loco parentis; or
16	(B) any other person related to the indi-
17	vidual by blood or marriage;
18	(4) the term "public safety officer" means an
19	individual serving a public agency in an official ca-

# 1SEC. 3. PROVIDING CAPITOL-FLOWN FLAGS FOR FAMILIES2OF FALLEN HEROES.

3 (a) IN GENERAL.—At the request of an immediate
4 family member of a firefighter, law enforcement officer,
5 member of a rescue squad or ambulance crew, or public
6 safety officer who died in the line of duty, the Representa7 tive or Senator of the family may provide to the family
8 a Capitol-flown flag, together with the certificate described
9 in subsection (c).

(b) NO COST TO FAMILY.—A Capitol-flown flag provided under this section shall be provided at no cost to
the family.

13 (c) CERTIFICATE.—The certificate described in this 14 subsection is a certificate which is signed by the Speaker of the House of Representatives and the Representative, 15 16 or the President pro tempore of the Senate and the Sen-17 ator, providing the Capitol-flown flag, as applicable, and which contains an expression of sympathy for the family 18 19 involved from the House of Representatives or the Senate, 20 as applicable.

### 21 SEC. 4. REGULATIONS AND PROCEDURES.

(a) IN GENERAL.—Not later than 30 days after the
date of enactment of this Act, the Architect of the Capitol
shall issue regulations for carrying out this Act, including
regulations to establish procedures (including any appro-

priate forms, guidelines, and accompanying certificates)
 for requesting a Capitol-flown flag.

3 (b) REVIEW.—The regulations issued under sub-4 section (a) shall take effect upon approval by the Com-5 mittee on House Administration of the House of Rep-6 resentatives and the Committee on Rules and Administra-7 tion of the Senate.

### 8 SEC. 5. AUTHORIZATION OF APPROPRIATIONS.

9 There are authorized to be appropriated to carry out
10 this Act for fiscal years 2017 through 2022 an aggregate
11 amount of \$40,000.

### 12 SEC. 6. EFFECTIVE DATE.

13 This Act shall take effect on the date of enactment 14 of this Act, except that a Capitol-flown flag may not be 15 provided under section 3 until the regulations issued under 16 section 4(a) take effect in accordance with section 4(b).
