# **A BILL**

To modify the boundary of the Shiloh National Military Park located in Tennessee and Mississippi, to establish Parker's Crossroads Battlefield as an affiliated area of the National Park System, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Shiloh National Mili-*  
5 *tary Park Boundary Adjustment and Parker’s Crossroads*  
6 *Battlefield Designation Act”.*

7 **SEC. 2. DEFINITIONS.**

8 *In this Act, the following definitions apply:*

9 (1) *AFFILIATED AREA.*—*The term “affiliated*  
10 *area” means the Parker’s Crossroads Battlefield estab-*  
11 *lished as an affiliated area of the National Park Sys-*  
12 *tem under section 4.*

13 (2) *PARK.*—*The term “Park” means Shiloh Na-*  
14 *tional Military Park, a unit of the National Park*  
15 *System.*

16 (3) *SECRETARY.*—*The term “Secretary” means*  
17 *the Secretary of the Interior.*

18 **SEC. 3. AREAS TO BE ADDED TO SHILOH NATIONAL MILLI-**  
19 **TARY PARK.**

20 (a) *ADDITIONAL AREAS.*—*The boundary of Shiloh Na-*  
21 *tional Military Park is modified to include the areas that*  
22 *are generally depicted on the map entitled “Shiloh National*  
23 *Military Park, Proposed Boundary Adjustment”, numbered*  
24 *304/80,011, and dated July 2014, as follows:*

25 (1) *Fallen Timbers Battlefield.*

1           (2) *Russell House Battlefield.*

2           (3) *Davis Bridge Battlefield.*

3           (b) *ACQUISITION AUTHORITY.*—*The Secretary may ac-*  
4 *quire lands described in subsection (a) by donation, pur-*  
5 *chase from willing sellers with donated or appropriated*  
6 *funds, or exchange.*

7           (c) *ADMINISTRATION.*—*Any lands acquired under this*  
8 *section shall be administered as part of the Park.*

9 **SEC. 4. ESTABLISHMENT OF AFFILIATED AREA.**

10          (a) *IN GENERAL.*—*Parker’s Crossroads Battlefield in*  
11 *the State of Tennessee is hereby established as an affiliated*  
12 *area of the National Park System.*

13          (b) *DESCRIPTION.*—*The affiliated area shall consist of*  
14 *the area generally depicted within the “Proposed Bound-*  
15 *ary” on the map entitled “Parker’s Crossroads Battlefield,*  
16 *Proposed Boundary”, numbered 903/80,073, and dated*  
17 *July 2014.*

18          (c) *ADMINISTRATION.*—*The affiliated area shall be*  
19 *managed in accordance with this Act and all laws generally*  
20 *applicable to units of the National Park System.*

21          (d) *MANAGEMENT ENTITY.*—*The City of Parkers*  
22 *Crossroads and the Tennessee Historical Commission shall*  
23 *jointly be the management entity for the affiliated area.*

24          (e) *COOPERATIVE AGREEMENTS.*—*The Secretary may*  
25 *provide technical assistance and enter into cooperative*

1 *agreements with the management entity for the purpose of*  
2 *providing financial assistance with marketing, marketing,*  
3 *interpretation, and preservation of the affiliated area.*

4 (f) *LIMITED ROLE OF THE SECRETARY.*—*Nothing in*  
5 *this Act authorizes the Secretary to acquire property at the*  
6 *affiliated area or to assume overall financial responsibility*  
7 *for the operation, maintenance, or management of the affi-*  
8 *ated area.*

9 (g) *GENERAL MANAGEMENT PLAN.*—

10 (1) *IN GENERAL.*—*The Secretary, in consultation*  
11 *with the management entity, shall develop a general*  
12 *management plan for the affiliated area. The plan*  
13 *shall be prepared in accordance with section 100502*  
14 *of title 54, United States Code.*

15 (2) *TRANSMITTAL.*—*Not later than 3 years after*  
16 *the date that funds are made available for this Act,*  
17 *the Secretary shall provide a copy of the completed*  
18 *general management to the Committee on Natural Re-*  
19 *sources of the House of Representatives and the Com-*  
20 *mittee on Energy and Natural Resources of the Sen-*  
21 *ate.*
