## A BILL

To restrict the inclusion of social security account numbers on documents sent by mail by the Federal Government, and for other purposes.

- 4 SEC. 2. RESTRICTION OF SOCIAL SECURITY NUMBERS ON
- 5 DOCUMENTS SENT BY MAIL.
- 6 (a) Restriction.—An agency may not include the
- 7 social security account number of an individual on any
- 8 document sent by mail unless the head of the agency de-
- 9 termines that the inclusion of the social security account
- 10 number on the document is necessary.
- 11 (b) REGULATIONS.—Not later than 5 years after the
- 12 date of the enactment of this Act, the head of each CFO
- 13 Act agency shall issue regulations specifying the cir-
- 14 cumstances under which inclusion of a social security ac-
- 15 count number on a document sent by mail is necessary.
- 16 Such regulations shall include—
- 17 (1) instructions for the partial redaction of so-
- cial security account numbers where feasible; and
- 19 (2) a requirement that social security account
- 20 numbers not be visible on the outside of any package
- 21 sent by mail.
- (c) Report.—Not later than 30 days after the date
- 23 of the enactment of this Act, and not later than the first,
- 24 second, third, fourth, and fifth-year anniversary of such
- 25 date of enactment, the head of each CFO Act agency shall
- 26 submit to the Committee on Ways and Means and the

4	Affairs of the Senate, and any other appropriate author-
5	izing committees of the House of Representatives and the

8	(1) The title and identification number of any
9	document used by the CFO Act agency during the
10	previous year that includes the complete social secu-
11	rity account number of an individual.
12	(2) For the first report submitted, a plan that
13	describes how the CFO Act agency will comply with
14	the requirements of subsection (a).
15	(3) For the final report submitted, the title and
16	identification number of each document used by the
17	CFO Act agency for which the head of the agency
18	has determined, in accordance with regulations
19	issued pursuant to subsection (b), that the inclusion
20	of a social security account number on such docu-
21	ment is necessary, and the rationale for such deter-
22	mination.
23	(4) For any other report that is not the first or
24	final report submitted, an update on the implemen-
25	tation of the plan described under paragraph (2).

1	(d) Definitions.—In this section:
2	(1) Agency.—The term "agency" has the
3	meaning given that term in section 551 of title 5,
4	United States Code, but includes an establishment
5	in the legislative or judicial branch of the Govern-
6	ment (except the Senate, the House of Representa-
7	tives, and the Architect of the Capitol, and any ac-
8	tivities under the direction of the Architect of the
9	Capitol).
10	(2) CFO ACT AGENCY.—The term "CFO Act
11	agency" means the agencies listed in paragraphs (1)
12	and (2) of section 901(b) of title 31, United States
13	Code.
14	(e) Effective Date.—Subsection (a) shall apply
15	with respect to any document sent by mail on or after
16	the date that is 5 years after the date of the enactment
17	of this Act.
