CORRECTION—COMMITTEE VOTES

Pursuant to clause 3(a)(2) of rule XIII of the Rules of the House of Representatives for the 115th Congress, the Committee on Ways and Means is filing this supplemental report to correct errors in the report to accompany H.R. 2824, To amend title V of the Social Security Act to extend the Maternal, Infant, and Early Childhood Home Visiting Program (H. Rept. 115-315, Part 1).

In the original report, an error appears in the rollcall votes on:

- Mr. Roskam’s motion to table Mr. Doggett’s appeal of the ruling of the Chair;
