To amend the Small Business Act to reauthorize the SCORE program, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This title may be cited as the "SCORE for Small
- 5 Business Act of 2018".
- 6 SEC. 2. SCORE REAUTHORIZATION.
- 7 Section 20 of the Small Business Act (15 U.S.C. 631
