- 4 SEC. 2. NATIONAL RECOVERY HOUSING BEST PRACTICES.
- 5 Part P of title III of the Public Health Service Act
- 6 is amended by adding at the end the following new section:
- 7 "SEC. 399V-7. NATIONAL RECOVERY HOUSING BEST PRAC-
- 8 TICES.
- 9 "(a) Best Practices.—The Secretary of Health
- 10 and Human Services, in consultation with the Secretary
- 11 for Housing and Urban Development, patients with a his-
- 12 tory of opioid use disorder, and other stakeholders, which
- 13 may include State accrediting entities and reputable pro-
- 14 viders, analysts, and stakeholders of recovery housing
- 15 services, such as the National Alliance for Recovery Resi-
- 16 dences, shall identify or facilitate the development of best
- 17 practices, which may include model laws for implementing
- 18 suggested minimum standards, for operating recovery

10	eral States, the District of Columbia, each Indian

13	and Education Assistance Act), and any territory or
14	possession of the United States.
15	"(d) Authorization of Appropriations.—To
16	carry out this section, there is authorized to be appro-
17	priated \$3,000,000 for the period of fiscal years 2019
18	through 2021.".
