#### 1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Correcting Miscalcula-3 tions in Veterans' Pensions Act".

# 4 SEC. 2. ERROR IN PROCESSING OF ANNUITY DEPOSIT FOR 5 FORMER MEMBERS OF THE UNIFORMED 6 SERVICES.

7 (a) CSRS.—Section 8334(j) of title 5, United States8 Code, is amended by adding at the end the following:

9 "(6)(A) In calculating and processing the deposit 10 under paragraph (1) with respect to an employee, Mem-11 ber, or annuitant, if the employing agency of such em-12 ployee, Member, or annuitant makes an administrative 13 error, such employing agency may pay, on behalf of the 14 employee, Member, or annuitant, any additional interest 15 assessed due to the administrative error.

"(B) For purposes of subparagraph (A), the Secretary of the Senate or the Chief Administrative Officer
of the House of Representatives, as appropriate, shall be
considered the employing agency of a Member or Congressional employee.

the employee, Member, or annuitant, any additional inter est assessed due to the administrative error.

5 "(B) In calculating and processing the deposit under paragraph (1) with respect to an employee, Member, or 6 7 annuitant, if the Office of Personnel Management makes 8 an administrative error that causes additional interest as-9 sessed to accrue on the deposit, the Office of Personnel 10 Management may pay, on behalf of the employee, Member, 11 or annuitant, any additional interest assessed due to the 12 administrative error.

"(C) For purposes of subparagraph (A), the Secretary of the Senate or the Chief Administrative Officer
of the House of Representatives, as appropriate, shall be
considered the employing agency of a Member or congressional employee.

(c) AUTHORIZATION OF PAYMENTS.—All payments
from the Office of Personnel Management authorized by

Retirement and Disability Fund, and together with administrative expenses incurred by the Office in administering
