(The amendment strikes all after the enacting clause and inserts a new text)

Mr. PASCRELL (for himself and Mr. THOMAS J. ROONEY of Florida) introduced the following bill; which was referred to the Committee on Energy and Commerce

A BILL

To reauthorize the Traumatic Brain Injury program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Traumatic Brain In-
5 jury Program Reauthorization Act of 2018”.

6 **SEC. 2. PREVENTION AND CONTROL OF INJURIES.**

7 Part J of title III of the Public Health Service Act
8 (42 U.S.C. 280b et seq.) is amended—

1 (1) in section 393C (42 U.S.C. 280b–1d) by
2 adding at the end the following:

3 “(c) NATIONAL CONCUSSION SURVEILLANCE SYS-
4 TEM.—The Secretary, acting through the Director of the
5 Centers for Disease Control and Prevention, may imple-
6 ment a national concussion surveillance system to deter-
7 mine the prevalence and incidence of concussion.”; and

8 (2) in section 394A (42 U.S.C. 280b–3)—

9 (A) in subsection (b)—

10 (i) by striking “393B and 393C” and
11 inserting “393B, 393C(a), and 393C(b)”;

12 and

13 (ii) by striking “\$6,564,000 for each
14 of fiscal years 2015 through 2019” and in-
15 sserting “\$6,750,000 for each of fiscal
16 years 2019 through 2023”; and

17 (B) by adding at the end the following:

18 “(c) NATIONAL CONCUSSION SURVEILLANCE SYS-
19 TEM.—To carry out section 393C(e), there are authorized
20 to be appropriated \$5,000,000 for each of fiscal years
21 2019 through 2023.”.

22 **SEC. 3. STATE GRANTS FOR PROJECTS REGARDING TRAUMATIC BRAIN INJURY.**

24 Section 1252 of the Public Health Service Act (42
25 U.S.C. 300d–52) is amended—

1 (1) in subsection (a), by inserting “, acting
2 through the Administrator for the Administration
3 for Community Living,” after “The Secretary”;

4 (2) by striking subsection (e);

5 (3) by redesignating subsections (f) through (j)
6 as subsections (e) through (i), respectively; and

7 (4) in subsection (i), as so redesignated, by
8 striking “\$5,500,000 for each of the fiscal years
9 2015 through 2019” and inserting “\$7,321,000 for
10 each of fiscal years 2019 through 2023”.

11 **SEC. 4. STATE GRANTS FOR PROTECTION AND ADVOCACY**
12 **SERVICES.**

13 Section 1253 of the Public Health Service Act (42
14 U.S.C. 300d–53) is amended—

15 (1) in subsection (a), by inserting “, acting
16 through the Administrator for the Administration
17 for Community Living,” after “The Secretary”; and

18 (2) in subsection (l), by striking “\$3,100,000
19 for each of the fiscal years 2015 through 2019” and
20 inserting “\$4,000,000 for each of fiscal years 2019
21 through 2023”.
