3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Preventing Online

1	SEC. 2. AMENDMENTS TO THE JENKINS ACT.
2	(a) IN GENERAL.—The Act entitled "An Act to assist

 (b) EFFECTIVE DATE.—This section, and the amend-

9 SEC. 3. NONMAILABILITY OF ELECTRONIC NICOTINE DE10 LIVERY SYSTEMS.

11 (a) REGULATIONS.—Not later than 120 days after 12 the date of enactment of this Act, the United States Postal 13 Service shall promulgate regulations to clarify the applicability of the prohibition on mailing of cigarettes under sec-14 15 tion 1716E of title 18, United States Code, to electronic nicotine delivery systems, in accordance with the amend-16 ment to the definition of "cigarette" made by section 2. 17 18 (b) EFFECTIVE DATE.—The prohibition on mailing of cigarettes under section 1716E of title 18, United 19 20 States Code, shall apply to electronic nicotine delivery sys-21 tems on and after the date on which the United States 22 Postal Service promulgates regulations under subsection 23 (a) of this section.

1 SEC. 4. DETERMINATION OF BUDGETARY EFFECTS.
