## A BILL

To direct the Attorney General to establish and carry out a Veteran Treatment Court Program.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Veteran Treatment
- 5 Court Coordination Act of 2019".
- 6 SEC. 2. SENSE OF CONGRESS.
- 7 It is the sense of Congress that veterans treatment
- 8 courts are a successful program aimed at helping veterans
- 9 charged with non-violent crimes receive the help and the
- 10 benefits for which the veterans are entitled.
- 11 SEC. 3. VETERAN TREATMENT COURT PROGRAM.
- 12 (a) Establishment.—Subject to the availability of
- 13 appropriations, in coordination with the Secretary of Vet-
- 14 erans Affairs, the Attorney General shall establish and
- 15 carry out a Veteran Treatment Court Program to provide
- 16 grants and technical assistance to court systems that—
- 17 (1) have adopted a Veterans Treatment Court
- 18 Program; or
- 19 (2) have filed a notice of intent to establish a
- 20 Veterans Treatment Court Program with the Sec-
- 21 retary.

- 1 (b) Purpose.—The purpose of the Veterans Treat-
- 2 ment Court Program established under subsection (a) is
- 3 to ensure the Department of Justice has a single office
- 4 to coordinate the provision of grants, training, and tech-
- 5 nical assistance to help State, local, and Tribal govern-
- 6 ments to develop and maintain veteran treatment courts.
- 7 (c) Programs Included.—The Veterans Treatment
- 8 Court Program established under subsection (a) shall in-
- 9 clude the grant programs relating to veterans treatment
- 10 courts carried out by the Attorney General pursuant to
- 11 sections 2901, 2991, and 3021 of the Omnibus Crime
- 12 Control and Safe Streets Act of 1968 (34 U.S.C. 10581,
- 13 10651, and 10701) or any other provision of law.
- 14 (d) REGULATIONS.—The Attorney General shall pro-
- 15 mulgate regulations to carry out this section.
