A BILL

To redesignate the Weir Farm National Historic Site in the State of Connecticut as the “Weir Farm National Historical Park”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Weir Farm National
5 Historical Park Redesignation Act”.

6 **SEC. 2. WEIR FARM NATIONAL HISTORICAL PARK.**

7 (a) IN GENERAL.—The Weir Farm National Historic
8 Site shall be known and designated as the “Weir Farm
9 National Historical Park”.

10 (b) AMENDMENTS TO THE WEIR FARM NATIONAL
11 HISTORIC SITE ESTABLISHMENT ACT OF 1990.—The
12 Weir Farm National Historic Site Establishment Act of
13 1990 (54 U.S.C. 320101 note; Public Law 101–485; 104
14 Stat. 1171; 108 Stat. 4756; 112 Stat. 3296; 123 Stat.
15 1190) is amended—

16 (1) in section 2(2)—

17 (A) by striking “historic site” and insert-
18 ing “historical park”; and

19 (B) by striking “National Historic Site”
20 and inserting “National Historical Park”;

21 (2) in section 4—

22 (A) in the heading, by striking “historic
23 site” and inserting “historical park”;

24 (B) in subsection (a), by striking “Historic
25 Site” and inserting “Historical Park”; and

1 (C) by striking “historic site” each place it
2 appears and inserting “historical park”;

3 (3) in section 5, by striking “historic site” each
4 place it appears and inserting “historical park”; and

5 (4) in section 6—

6 (A) in the heading, by striking “historic
7 site” and inserting “historical park”; and

8 (B) by striking “historic site” each place it
9 appears and inserting “historical park”.

10 (c) REFERENCES.—Any reference in any law, regula-
11 tion, document, record, map, or other paper of the United
12 States to the Weir Farm National Historic Site shall be
13 considered to be a reference to the “Weir Farm National
14 Historical Park”.
