## A BILL

To direct the Secretary of Veterans Affairs to submit to Congress periodic reports on the costs of the Department of Veterans Affairs Electronic Health Record Modernization program.

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "VA Electronic Health

1	SEC. 2. REPORTS ON COSTS, PERFORMANCE METRICS, AND
2	OUTCOMES OF DEPARTMENT OF VETERANS

5	(a) In General.—Section 503 of the Veterans Bene-
6	fits and Transition Act of 2018 (Public Law 115–407; $38$
7	U.S.C. 5701 note prec.) is amended—
8	(1) by redesignating subsection (e) as sub-
9	section (f);
10	(2) by inserting after subsection (d) the fol-
11	lowing new subsection (e):
12	"(e) Quarterly Reports.—
13	"(1) Reports on costs of ehrm program.—
14	Not later than 90 days after the date of the enact-
15	ment of the VA Electronic Health Record Trans-
16	parency Act of 2021, and every 30 days after the
17	last day of each fiscal quarter thereafter until the
18	termination date specified in paragraph (3), the Sec-
19	retary of Veterans Affairs shall submit to the Com-
20	mittees on Veterans' Affairs of the Senate and

10	for the Electronic Health Record Modernization

12	"(B) any funds, from any source or ac-
13	count, expended by any organizational element
14	of the Department for physical or technology
15	infrastructure modifications, enhancements, im-
16	provements, or expansions at a facility of the
17	Department necessitated by, or related or per-
18	taining to, the Electronic Health Record Mod-
19	ernization Program; and
20	"(C) any funds, from any source or ac-
21	count, expended by any organizational element
22	of the Department or by the Federal Electronic
23	Health Record Modernization Office for con-
24	sultants, support contractors, or experts related

2	Modernization Program.
3	"(2) Reports on Performance metrics and
4	OUTCOMES.—Not later than 90 days after the date
5	of the enactment of the VA Electronic Health
6	Record Transparency Act of 2021, and every 30
7	days after the last day of each fiscal quarter there-
8	after until the termination date specified in para-
9	graph (3), the Secretary of Veterans Affairs shall
10	submit to the Committees on Veterans' Affairs of
11	the Senate and House of Representatives a report on
12	the performance metrics and outcomes of the Elec-
13	tronic Health Record Modernization Program. Each
14	such report shall include, for the period covered by
15	the report—
16	"(A) a list of the quality, performance,
17	safety, or value metrics, key performance indi-
18	cators, and other diagnostic or evaluation cri-
19	teria in use to assess the Electronic Health
20	Record Modernization Program and the elec-
21	tronic health record system, in general and at
22	individual facilities, with respect to veterans,
23	employees of the Department, and Depart-
24	mental operations;

1	"(B) an explanation of any change to any
2	of such metrics, indicators, and criteria com-
3	pared to the metrics, indicators, and criteria in-
4	cluded in any previous report submitted under
5	this paragraph;
6	"(C) the data supporting or demonstrating
7	each such metric, indicator, and criteria com-
8	pared to the data supporting or demonstrating
9	such metric, indicator, or criteria as included in
10	the previous report submitted under this para-
11	graph; and
12	"(D) a list of patient safety reports, inci-
13	dents, alerts, or disclosures at each facility of
14	the Department where the electronic health
15	record system has been implemented.
16	"(3) Termination date.—The requirement to
17	submit a report under paragraph (1) shall terminate
18	on the date that is 90 days after the date on which
19	the Secretary submits to the Committees on Vet-
20	erans' Affairs of the Senate and House of Rep-
21	resentatives certification that the Electronic Health
22	Record Modernization program has been fully imple-
23	mented."; and

1	(3) in subsection (f), as redesignated by para-
2	graph (1), by adding at the end the following new
3	paragraphs:
4	"(3) The term 'electronic health record system'
5	means the electronic health record system imple-
6	mented pursuant to the Electronic Health Record

9	Record Management Office' means the office estab-

11	rior Act (title XVI of Public Law 110–181; 10

14	cludes a joint facility of the Department of Veterans
