4	(a) Prohibition on Collection.—Chapter 17 of

12	"(a) Prohibition.—Except as provided in sub-

24	``(c) Mental Health Care Outpatient Visit De-
25	FINED.—In this section, the term 'mental health care out-
26	patient visit' means an outpatient visit with a qualified

- 4 (b) APPLICABILITY.—The amendments made by sub-
- 5 section (a) shall apply with respect to mental health care
