- 4 vided and controlled by the chair and ranking minority
- 5 member of the Committee on Veterans' Affairs or their
- 6 respective designees; and (2) one motion to recommit.
- 7 Sec. 2. Upon adoption of this resolution it shall be
- 8 in order to consider in the House the bill (S. 3905) to
- 9 prevent organizational conflicts of interest in Federal ac-
- 10 quisition, and for other purposes. All points of order
- 11 against consideration of the bill are waived. The bill shall
- 12 be considered as read. All points of order against provi-
- 13 sions in the bill are waived. The previous question shall
- 14 be considered as ordered on the bill and on any amend-
- 15 ment thereto to final passage without intervening motion
- 16 except: (1) one hour of debate equally divided and con-
- 17 trolled by the chair and ranking minority member of the
- 18 Committee on Oversight and Reform or their respective
- 19 designees; and (2) one motion to commit.
- Sec. 3. Upon adoption of this resolution it shall be
- 21 in order to consider in the House the bill (S. 4003) to
- 22 amend the Omnibus Crime Control and Safe Streets Act
- 23 of 1968 to provide for training on alternatives to use of
- 24 force, de-escalation, and mental and behavioral health and
- 25 suicidal crises. All points of order against consideration

- 1 of the bill are waived. The bill shall be considered as read.
- 2 All points of order against provisions in the bill are
- 3 waived. The previous question shall be considered as or-
- 4 dered on the bill and on any amendment thereto to final
- 5 passage without intervening motion except: (1) one hour
- 6 of debate equally divided and controlled by the chair and
- 7 ranking minority member of the Committee on the Judici-
- 8 ary or their respective designees; and (2) one motion to
- 9 commit.
- SEC. 4. House Resolution 1516 is hereby adopted.
- 11 Sec. 5. (a) At any time through the legislative day
- 12 of Thursday, December 15, 2022, the Speaker may enter-
- 13 tain motions offered by the Majority Leader or a designee
- 14 that the House suspend the rules as though under clause
- 15 1 of rule XV with respect to multiple measures described
- 16 in subsection (b), and the Chair shall put the question on
- 17 any such motion without debate or intervening motion.
- 18 (b) A measure referred to in subsection (a) includes
- 19 any measure that was the object of a motion to suspend
- 20 the rules on the legislative day of December 12, 2022, De-
- 21 cember 13, 2022, December 14, 2022, or December 15,
- 22 2022, in the form as so offered, on which the year and
- 23 nays were ordered and further proceedings postponed pur-
- 24 suant to clause 8 of rule XX.

- 1 (c) Upon the offering of a motion pursuant to sub-
- 2 section (a) concerning multiple measures, the ordering of
- 3 the year and nays on postponed motions to suspend the
- 4 rules with respect to such measures is vacated to the end
- 5 that all such motions are considered as withdrawn.
- 6 Sec. 6. Notwithstanding clause 8 of rule XX, further
- 7 proceedings on a vote by the year and nays on the question
- 8 of adoption of a motion that the House suspend the rules
- 9 offered on the legislative day of December 12, 2022 may
- 10 be postponed through the legislative day of December 15,
- 11 2022.
- 12 Sec. 7. Upon adoption of this resolution it shall be
- 13 in order to take from the Speaker's table the bill (H.R.
- 14 1437) to amend the Weather Research and Forecasting
- 15 Innovation Act of 2017 to direct the National Oceanic and
- 16 Atmospheric Administration to provide comprehensive and
- 17 regularly updated Federal precipitation information, and
- 18 for other purposes, with the Senate amendment thereto,
- 19 and to consider in the House, without intervention of any
- 20 point of order, a motion offered by the chair of the Com-
- 21 mittee on Appropriations or her designee that the House
- 22 concur in the Senate amendment with an amendment con-
- 23 sisting of the text of Rules Committee Print 117-72. The
- 24 Senate amendment and the motion shall be considered as
- 25 read. The motion shall be debatable for one hour equally

- 1 divided and controlled by the chair and ranking minority
- 2 member of the Committee on Appropriations or their re-
- 3 spective designees. The previous question shall be consid-
- 4 ered as ordered on the motion to its adoption without in-
- 5 tervening motion.
- 6 Sec. 8. Upon adoption of this resolution, the House
- 7 shall be considered to have taken from the Speaker's table
- 8 the bill (H.R. 2617) to amend section 1115 of title 31,
- 9 United States Code, to amend the description of how per-
- 10 formance goals are achieved, and for other purposes, with
- 11 the Senate amendments thereto, to have concurred in the
- 12 Senate amendments numbered 1, 2, 3, and 5, and to have
- 13 concurred in the Senate amendment numbered 4 with an
- 14 amendment consisting of the text of Rules Committee
- 15 Print 117-73.
