1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Disaster Offset and
5 Government Efficiency Act”.

1 **SEC. 2. REVISION OF FISCAL YEAR 2025 DISCRETIONARY**
2 **SPENDING LIMIT FOR REVISED NONSECU-**
3 **RITY CATEGORY.**

4 Section 251 of the Balanced Budget and Emergency
5 Deficit Control Act of 1985 (2 U.S.C. 901(e)(10)(B)) is
6 amended—

7 (1) in subsection (e)(10)(B), by striking the
8 dollar amount and inserting “\$597,000,000,000”;
9 and

10 (2) in subsection (e)(1)—

11 (A) by striking “, as follows:” and insert-
12 ing “for the revised security category, the
13 amount calculated for such category in section
14 (d)(1)(A).”; and

15 (B) by striking subparagraphs (A) and
16 (B).

17 **SEC. 3. RESCISSION OF AMOUNTS APPROPRIATED FOR DE-**
18 **PARTMENT OF COMMERCE NONRECURRING**
19 **EXPENSES FUND.**

20 (a) RESCISSION.—The total amount of unobligated
21 funds made available by section 101(e) of the Fiscal Re-
22 sponsibility Act of 2023 (Public Law 118–5) for the De-
23 partment of Commerce Nonrecurring Expenses Fund are
24 hereby permanently rescinded.

25 (b) CLASSIFICATION OF BUDGETARY EFFECTS.—
26 The budgetary effects of subsection (a) shall not count for

1 purposes of section 251 of the Balanced Budget and
2 Emergency Deficit Control Act of 1985 or allocation pur-
3 suant to section 302(a) or 302(b) of the Congressional
4 Budget Act of 1974.
