**A BILL**

To amend the Small Business Act to include requirements relating to new small business entrants in the scorecard program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Small Business Pro-  
5 curement and Utilization Reform Act of 2025” or the  
6 “SPUR Act”.

1 **SEC. 2. MODIFICATIONS TO SCORECARD REQUIREMENTS.**

2 Section 15(y) of the Small Business Act (15 U.S.C.  
3 644(y)) is amended—

4 (1) in paragraph (2)—

5 (A) by redesignating subparagraph (E) as  
6 subparagraph (F); and

7 (B) by inserting after subparagraph (D)  
8 the following new subparagraph:

9 “(E) The number of new small business  
10 entrants, including new small business entrants  
11 that are small business concerns owned and  
12 controlled by service-disabled veterans, qualified  
13 HUBZone small business concerns, small busi-  
14 ness concerns owned and controlled by socially  
15 and economically disadvantaged individuals, and  
16 small business concerns owned and controlled  
17 by women awarded prime contracts in each  
18 North American Industry Classification System  
19 code during the fiscal year, and a comparison  
20 to the number awarded prime contracts during  
21 the prior fiscal year, if available.”;

22 (2) in paragraph (3), by striking “subpara-  
23 graphs (B) through (E) of paragraph (2)” and in-  
24 serting “subparagraphs (B) through (F) of para-  
25 graph (2)”;

1           (3) by amending paragraph (6) to read as fol-  
2           lows:

3           “(6) DEFINITIONS.—In this subsection:

4           “(A) NEW SMALL BUSINESS ENTRANT.—  
5           The term ‘new small business entrant’ means a  
6           small business concern that—

7                   “(i) has been awarded a prime con-  
8                   tract by a Federal agency; and

9                   “(ii) has not previously been awarded  
10                  a prime contract by any Federal agency.

11           “(B) SCORECARD.—The term ‘scorecard’  
12           means any summary using a rating system to  
13           evaluate the efforts of a Federal agency to meet  
14           goals established under subsection (g)(1)(B)  
15           that—

16                   “(i) includes the measures described  
17                   in paragraph (2); and

18                   “(ii) assigns a score to each Federal  
19                   agency evaluated.”.

20   **SEC. 3. COMPLIANCE WITH CUTGO.**

21           No additional amounts are authorized to be appro-  
22           priated to carry out this Act or the amendments made  
23           by this Act.
