A BILL

To amend title 38, United States Code, to provide clarification regarding the inclusion of medically necessary automobile adaptations in Department of Veterans Affairs definition of “medical services”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Automotive Support*
5 *Services to Improve Safe Transportation Act of 2025” or*
6 *the “ASSIST Act of 2025”.*

7 **SEC. 2. CLARIFICATION REGARDING INCLUSION OF MEDI-**
8 **CALLY NECESSARY AUTOMOBILE ADAPTA-**
9 **TIONS IN DEPARTMENT OF VETERANS AF-**
10 **FAIRS DEFINITION OF “MEDICAL SERVICES”.**

11 *Section 1701(6)(I) of title 38, United States Code, is*
12 *amended to read as follows:*

13 *“(I) The provision of any medically necessary*
14 *automobile adaptations for driver or passenger use,*
15 *including—*

16 *“(i) ramp and kneeling systems;*

17 *“(ii) raised doors or lowered floors;*

18 *“(iii) raised roofs;*

19 *“(iv) air conditioning;*

20 *“(v) occupied and unoccupied mobility lifts;*

21 *“(vi) ingress or egress accessibility modi-*
22 *fications;*

23 *“(vii) wheelchair tiedowns; and*

24 *“(viii) adapted seating.”.*

1 ***SEC. 3. EXTENSION OF CERTAIN LIMITS ON PAYMENTS OF***
2 ***PENSION.***

4 *amended by striking “November 30, 2031” and inserting*
5 *“September 30, 2032”.*
