## A BILL

To amend and reauthorize the Staff Sergeant Parker Gordon Fox Suicide Prevention Grant Program of the Department of Veterans Affairs.

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "No Wrong Door for Vet-
5	erans Act".
6	SEC. 2. REAUTHORIZATION AND IMPROVEMENT OF STAFF
7	SERGEANT PARKER GORDON FOX SUICIDE
8	PREVENTION GRANT PROGRAM OF DEPART-
9	MENT OF VETERANS AFFAIRS.
10	(a) Duration.—Section 201 of the Commander John
11	Scott Hannon Veterans Mental Health Care Improvement
12	Act of 2019 (Public Law 116–171; 38 U.S.C. 1720F note)
13	is amended, in subsection (j), by striking "the date that is
14	three years after the date on which the first grant is award-
15	ed under this section" and inserting "September 30, 2026".
16	(b) Emergent Suicide Care.—Such section is fur-
17	ther amended—
18	(1) in subsection (m)—
19	(A) by redesignating paragraph (3) as
20	paragraph (4);
21	(B) by inserting after paragraph (2) the fol-
22	lowing new paragraph (3):
23	"(3) Emergent suicide care.—In the case of
24	an eligible individual who receives suicide prevention
25	services provided or coordinated by an eligible entity

1	in receipt of a grant under this section, the eligible
2	entity shall notify—
3	"(A) the eligible individual that the indi-
4	vidual may be eligible for emergent suicide care
5	under section 1720J of title 38, United States
6	Code; and
7	"(B) the Secretary, if an eligible individual
8	notified under subparagraph (A) elects to receive
9	such emergent suicide care."; and
10	(C) in paragraph (4), as so redesignated, by
11	striking "(1) or (2)" and inserting "(1), (2), or
12	(3)"; and
13	(2) in subsection (n)—
14	(A) by inserting "(1) In General.—" be-
15	fore "When" and adjusting the margins accord-
16	ingly; and
17	(B) by adding at the end the following new
18	paragraph:
19	"(2) Time frame.—If the Secretary does not
20	provide services under paragraph (1) to an eligible
21	individual during the 72-hour period following a re-
22	ferral under subsection (m), such eligible individual
23	shall be treated as eligible for emergent suicide care
24	under section 1720J of title 38, United States Code.".

20	vider"; and
21	(3) in subparagraph (E), by striking "A" and
22	inserting "a".
