A BILL

To amend the Miccosukee Reserved Area Act to authorize the expansion of the Miccosukee Reserved Area and to carry out activities to protect structures within the Osceola Camp from flooding, and for other purposes. Be it enacted by the Senate and House of Representa tives of the United States of America in Congress assembled,
 SECTION 1. SHORT TITLE.
 This Act may be cited as the "Miccosukee Reserved
 Area Amendments Act".
 SEC. 2. MICCOSUKEE RESERVED AREA ADDITION.

7 Section 4(4) of the Miccosukee Reserved Area Act
8 (16 U.S.C. 410 note; Public Law 105–313) is amended
9 by adding at the end the following:

10 "(C) ADDITIONAL AREA.—In addition to 11 the land described in subparagraph (B), the 12 term 'Miccosukee Reserved Area' or 'MRA' includes the portion of the Park that is known as 13 14 'Osceola Camp' and is depicted on the map en-15 titled 'Everglades National Park, Proposed Ex-16 pansion–Miccosukee Reserved Area, Osceola 17 Camp', numbered 160/188443, and dated July 18 2023, copies of which shall—

19 "(i) be kept available for public in20 spection in the offices of the National Park
21 Service; and
22 "(ii) be filed with appropriate officers

23 of Miami-Dade County and the Tribe.".

1 SEC. 3. PROTECTION OF THE OSCEOLA CAMP FROM2FLOODING.

3 Section 8 of the Miccosukee Reserved Area Act (16
4 U.S.C. 410 note; Public Law 105–313) is amended by
5 adding at the end the following:

6 "(j) PROTECTION OF OSCEOLA CAMP FROM FLOOD-7 ING.—Not later than 2 years after the date of enactment 8 of this subsection, the Secretary, in consultation with the 9 Tribe, shall take appropriate actions to protect structures 10 within the area described in section 4(4)(C) from flood-11 ing.".
