A BILL

To amend title 38, United States Code, to modify the requirements of the Edith Nourse Rogers STEM Scholarship.

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Edith Nourse Rogers
5	STEM Scholarship Opportunity Act".
6	SEC. 2. MODIFICATIONS TO EDITH NOURSE ROGERS STEM
7	SCHOLARSHIP.
8	Section 3320 of title 38, United States Code, is amend-
9	ed—
10	(1) in subsection (b)—
11	(A) by striking paragraph (2);
12	(B) by redesignating paragraphs (3) and
13	(4) as paragraphs (2) and (3), respectively; and
14	(C) in paragraph (3), as so redesignated, in
15	subparagraph (A)(ii)—
16	(i) by striking "60" and inserting
17	"45"; and
18	(ii) by striking "90" and inserting
19	"67.5";
20	(2) in subsection (c)(1)—
21	(A) by redesignating subparagraphs (A)
22	and (B) as subparagraphs (C) and (D), respec-
23	tively; and

1	(B) by inserting before subparagraph (C),
2	as so redesignated, the following new subpara-
3	graphs:
4	"(A) Individuals who have used the most number
5	of months of the educational assistance to which they
6	are entitled under this chapter.
7	"(B) Individuals who are using their entitlement
8	under this chapter to pursue a program of post-sec-
9	ondary education and who have declared a major in
10	a field referred to in subsection $(b)(3)(A)(i)$."; and
11	(3) in subsection (d), by adding at the end the
12	following new paragraph:
13	"(5) An individual who receives a benefit under this
14	section may only use such benefit after the individual has
15	used all of the educational assistance to which the indi-
16	vidual is entitled under this chapter.".
17	SEC. 3. EXTENSION OF CERTAIN LIMITS ON PAYMENTS OF
18	PENSION.
19	Section 5503(d)(7) of title 38, United States Code, is
20	amended by striking "November 30, 2031" and inserting
21	"March 31, 2033".
