## A BILL

## 1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Fallen Servicemembers
- 3 Religious Heritage Restoration Act".
- 4 SEC. 2. FINDINGS.
- 5 Congress finds the following:
- 6 (1) An estimated 900 American-Jewish
- 7 servicemembers of the Armed Forces, killed in World
- 8 War I and World War II and buried overseas in
- 9 United States military cemeteries were, for various
- 10 reasons, mistakenly buried under Latin Crosses. In
- most instances, those mistakes were made inadvert-
- ently.
- 13 (2) In 2022, more than 2,000,000 people vis-
- ited the United States World War I and World War
- 15 II cemeteries in foreign countries.
- 16 (3) American-Jewish servicemembers played a
- vital role in the Allied victories in World War I and
- 18 World War II.
- 19 (4) American-Jewish servicemembers who
- fought and died for the United States must have
- 21 their heritage properly recognized and honored.
- 22 (5) The United States Government has a sol-
- emn responsibility to ensure that every American
- servicemember killed in action and buried overseas is
- properly honored.

1	(6) The work of properly identifying American-
2	Jewish servicemembers buried overseas is vital and
3	integral to the responsibility of the American Battle
4	Monuments Commission to ensure that past mis-
5	takes in honoring those servicemembers who died in
6	the line of duty are corrected.
7	SEC. 3. FALLEN SERVICEMEMBERS RELIGIOUS HERITAGE
8	RESTORATION PROGRAM.
9	(a) Establishment.—The American Battle Monu-
10	ments Commission shall establish a program to identify
11	covered members and to contact survivors and descend-
12	ants of such covered members. Such program shall be
13	known as the "Fallen Servicemembers Religious Heritage
14	Restoration Program".
15	(b) Duration.—The Commission shall carry out the
16	Fallen Servicemembers Religious Heritage Restoration
17	Program during the first five fiscal years that begin after
18	the date of the enactment of this Act.
19	(c) Contracts.—
20	(1) Authority.—During each fiscal year de-
21	scribed in subsection (b), the Commission shall seek
22	to enter into a contract with a nonprofit organiza-
23	tion under which such nonprofit organization shall
24	carry out the purpose described in subsection (a).

1	(2) TERM; AMOUNT.—Each contract under this
2	subsection shall be for one year and in the amount
3	of \$500,000 to the nonprofit organization.
4	(3) Priority.—In awarding a contract under
5	this subsection, the Commission shall give priority to
6	a nonprofit organization that has demonstrated ca-
7	pability and expertise in carrying out the purpose
8	described in subsection (a).
9	(d) Definitions.—In this section:
10	(1) The term "covered member" means a de-
11	ceased member of the Armed Forces who was Jew-
12	ish and buried—
13	(A) in a United States military cemetery
14	located outside the United States; and
15	(B) under a marker that indicates such
16	member was not Jewish.
17	(2) The term "nonprofit organization" means
18	an organization described in section $501(c)(3)$ of the
19	Internal Revenue Code of 1986 and exempt from
20	taxation under section 501(a) of such Code.
21	SEC. 4. EXTENSION OF CERTAIN LIMITS ON PAYMENTS OF
22	PENSION.
23	Section 5503(d)(7) of title 38, United States Code,
24	is amended by striking "November 30, 2031" and insert-
25	ing "January 31, 2032".
