A BILL

To amend title 38, United States Code, to direct the Secretary of Veterans Affairs to provide for electronic communication relating to educational assistance benefits under the laws administered by the Secretary, and for other purposes.

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Delivering Digitally to
5	Our Veterans Act of 2025".
6	SEC. 2. IMPROVEMENT TO CERTAIN OUTREACH UNDER
7	SOLID START PROGRAM OF DEPARTMENT OF
8	VETERANS AFFAIRS.
9	Section 6320(b) of title 38, United States Code, is
10	amended—
11	(1) in paragraph $(1)(B)$ —
12	(A) by striking "calling" and inserting
13	"communicating with"; and
14	(B) by inserting "through the use of tailored
15	lines of communication, including mailings, text
16	messaging, virtual chatting, and other electronic
17	forms of messaging" after "Armed Forces"; and
18	(2) in paragraph (2), by striking "tailored mail-
19	ings" and inserting "tailored lines of communication,
20	including mailings, text messaging, virtual chatting,
21	and other electronic forms of messaging.".

1	SEC. 3. DEPARTMENT OF VETERANS AFFAIRS USE OF TAI-
2	LORED LINES OF COMMUNICATION FOR COR-
3	RESPONDENCE RELATING TO EDUCATIONAL
4	ASSISTANCE BENEFITS.
5	Section 3680 of title 38, United States Code, is amend-
6	ed by adding at the end the following new subsection:
7	"(i)(1) The Secretary shall provide a mechanism by
8	which an eligible veteran or eligible person may use tailored
9	lines of communication to send and receive correspondence
10	with the Department of Veterans related to entitlement to
11	and use of educational assistance benefits under the laws
12	administered by the Secretary. The Secretary shall ensure
13	that an eligible veteran or eligible person is provided with
14	an opportunity to opt into sending and receiving such cor-
15	respondence using such lines of communication rather than
16	by mail.
17	"(2) The Secretary shall provide to eligible veterans
18	and eligible persons who are enrolled in a course or pro-
19	gram of education or training notice of the opportunity to
20	opt in to sending and receiving correspondence using tai-
21	lored lines of communication pursuant to paragraph (1).
22	"(3) In this subsection, the term 'tailored lines of com-
23	munication' includes mailings, text messaging, virtual
24	chatting, and other electronic forms of messaging.".
