1	SECTION 1. SHORT TITLE.
2	This Act may be cited as the "Syria Terrorism
3	Threat Assessment Act".
4	SEC. 2. THREAT ASSESSMENT OF TERRORIST THREATS
5	POSED BY INDIVIDUALS IN SYRIA WITH AN
6	AFFILIATION WITH A FOREIGN TERRORIST
7	ORGANIZATION OR A SPECIALLY DES-
8	IGNATED GLOBAL TERRORIST ORGANIZA-

10	(a) Terrorism Threat Assessment.—
11	(1) IN GENERAL.—The Secretary of Homeland
12	Security, in coordination with the heads of other rel-
13	evant Federal departments or agencies, shall con-
14	duct a threat assessment of terrorist threats to the
15	United States posed by individuals in Syria with an
16	affiliation with a foreign terrorist organization or a
17	specially designated global terrorist organization.
18	(2) Elements.—The threat assessment re-
19	quired under paragraph (1) shall include the fol-

21	(A) An identification of the country of ori-

4	(i) The capability of the Department

11	(i) Mitigating the terrorist threats to

16	(b) Congressional Notification.—
17	(1) In general.—Not later than 60 days after
18	the date of the enactment of this Act, the Secretary
19	shall—
20	(A) submit to the appropriate congres-
21	sional committees the threat assessment re-
22	quired under subsection (a); and
23	(B) provide a briefing to the appropriate
24	congressional committees on such assessment.

1	(2) FORM.—The threat assessment required
2	under subsection (a) shall be submitted in unclassi-
3	fied form, but may include a classified annex.
4	(e) Definitions.—In this Act:
5	(1) Appropriate congressional commit-
6	TEES.—The term "appropriate congressional com-
7	mittees" means—
8	(A) the Committee on Homeland Security
9	of the House of Representatives; and
10	(B) the Committee on Homeland Security
11	and Governmental Affairs of the Senate.
12	(2) Foreign terrorist organization.—The
13	term "foreign terrorist organization" means an or-
14	ganization designated as a foreign terrorist organiza-
15	tion under section 219 of the Immigration and Na-
16	tionality Act (8 U.S.C. 1189).
17	(3) Specially designated global ter-
18	RORIST ORGANIZATION.—The term "specially des-
19	ignated global terrorist organization" means an or-
20	ganization that has been designated as a specially
21	designated global terrorist organization by the Sec-
22	retary of State or the Secretary of the Treasury, as
23	the case may be, pursuant to Executive Order 13224
24	(50 U.S.C. 1701 note; relating to blocking property

- 2 mit, threaten to commit, or support terrorism).
