RESOLUTION

Providing for consideration of the bill (H.R. 139) to make daylight savings time permanent, and for other purposes; providing for consideration of the bill (H.R. 8595) making appropriations for national security, Department of State, and related programs for the fiscal year ending

September 30, 2027, and for other purposes; providing for consideration of the bill (H.R. 9237) to amend titles 10 and 38, United States Code, and other Federal laws, to improve benefits for veterans and the administration of the Department of Veterans Affairs; providing for consideration of the bill (H.R. 1181) to prohibit payment card networks and covered entities from requiring the use of or assigning merchant category codes that distinguish a firearms retailer from general-merchandise retailer or sporting-goods retailer, and for other purposes; and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 139) to make daylight savings time permanent, and for
4 other purposes. All points of order against consideration
5 of the bill are waived. The bill shall be considered as read.
6 All points of order against provisions in the bill are
7 waived. The previous question shall be considered as or-
8 dered on the bill and on any amendment thereto to final
9 passage without intervening motion except: (1) one hour
10 of debate equally divided and controlled by the chair and
11 ranking minority member of the Committee on Energy
12 and Commerce or their respective designees; and (2) one
13 motion to recommit.

14 SEC. 2. At any time after adoption of this resolution
15 the Speaker may, pursuant to clause 2(b) of rule XVIII,
16 declare the House resolved into the Committee of the
17 Whole House on the state of the Union for consideration

1 of the bill (H.R. 8595) making appropriations for national
2 security, Department of State, and related programs for
3 the fiscal year ending September 30, 2027, and for other
4 purposes. The first reading of the bill shall be dispensed
5 with. All points of order against consideration of the bill
6 are waived. General debate shall be confined to the bill
7 and shall not exceed one hour equally divided and con-
8 trolled by the chair and ranking minority member of the
9 Committee on Appropriations or their respective des-
10 ignees. After general debate the bill shall be considered
11 for amendment under the five-minute rule. The bill shall
12 be considered as read. Points of order against provisions
13 in the bill for failure to comply with clause 2 or clause
14 5(a) of rule XXI are waived.

15 SEC. 3. (a) No amendment to H.R. 8595 shall be in
16 order except those printed in part A of the report of the
17 Committee on Rules accompanying this resolution, amend-
18 ments en bloc described in section 4 of this resolution, and
19 pro forma amendments described in section 5 of this reso-
20 lution.

21 (b) Each amendment printed in part A of the report
22 of the Committee on Rules shall be considered only in the
23 order printed in the report, may be offered only by a Mem-
24 ber designated in the report, shall be considered as read,
25 shall be debatable for the time specified in the report

1 equally divided and controlled by the proponent and an
2 opponent, shall not be subject to amendment except as
3 provided by section 5 of this resolution, and shall not be
4 subject to a demand for division of the question in the
5 House or in the Committee of the Whole.

6 (c) All points of order against amendments printed
7 in part A of the report of the Committee on Rules or
8 against amendments en bloc described in section 4 of this
9 resolution are waived.

10 SEC. 4. It shall be in order at any time for the chair
11 of the Committee on Appropriations or his designee to
12 offer amendments en bloc consisting of amendments print-
13 ed in part A of the report of the Committee on Rules ac-
14 companying this resolution not earlier disposed of. Amend-
15 ments en bloc offered pursuant to this section shall be con-
16 sidered as read, shall be debatable for 20 minutes equally
17 divided and controlled by the chair and ranking minority
18 member of the Committee on Appropriations or their re-
19 spective designees, shall not be subject to amendment ex-
20 cept as provided by section 5 of this resolution, and shall
21 not be subject to a demand for division of the question
22 in the House or in the Committee of the Whole.

23 SEC. 5. During consideration of H.R. 8595 for
24 amendment, the chair and ranking minority member of
25 the Committee on Appropriations or their respective des-

1 ignees may offer up to 10 pro forma amendments each
2 at any point for the purpose of debate.

3 SEC. 6. At the conclusion of consideration of H.R.
4 8595 for amendment the Committee shall rise and report
5 the bill to the House with such amendments as may have
6 been adopted. The previous question shall be considered
7 as ordered on the bill and amendments thereto to final
8 passage without intervening motion except one motion to
9 recommit.

10 SEC. 7. Upon adoption of this resolution it shall be
11 in order to consider in the House the bill (H.R. 9237)
12 to amend titles 10 and 38, United States Code, and other
13 Federal laws, to improve benefits for veterans and the ad-
14 ministration of the Department of Veterans Affairs. All
15 points of order against consideration of the bill are waived.
16 The amendment printed in part B of the report of the
17 Committee on Rules accompanying this resolution shall be
18 considered as adopted. The bill, as amended, shall be con-
19 sidered as read. All points of order against provisions in
20 the bill, as amended, are waived. The previous question
21 shall be considered as ordered on the bill, as amended,
22 and on any further amendment thereto, to final passage
23 without intervening motion except: (1) one hour of debate
24 equally divided and controlled by the chair and ranking
25 minority member of the Committee on Veterans' Affairs

1 or their respective designees; and (2) one motion to recom-
2 mit.

3 SEC. 8. Upon adoption of this resolution it shall be
4 in order to consider in the House the bill (H.R. 1181)
5 to prohibit payment card networks and covered entities
6 from requiring the use of or assigning merchant category
7 codes that distinguish a firearms retailer from general-
8 merchandise retailer or sporting-goods retailer, and for
9 other purposes. All points of order against consideration
10 of the bill are waived. The amendment in the nature of
11 a substitute recommended by the Committee on Financial
12 Services now printed in the bill shall be considered as
13 adopted. The bill, as amended, shall be considered as read.
14 All points of order against provisions in the bill, as amend-
15 ed, are waived. The previous question shall be considered
16 as ordered on the bill, as amended, and on any further
17 amendment thereto, to final passage without intervening
18 motion except: (1) one hour of debate equally divided and
19 controlled by the chair and ranking minority member of
20 the Committee on Financial Services or their respective
21 designees; and (2) one motion to recommit.

22 SEC. 9. In the engrossment of H.R. 8595, the Clerk
23 shall—

24 (a) add the text of S. 1383, as passed by the House,
25 as new matter at the end of H.R. 8595;

1 (b) assign appropriate designations to provisions
2 within the engrossment;

3 (c) conform cross-references and provisions for short
4 titles within the engrossment; and

5 (d) be authorized to make technical corrections, to
6 include corrections in spelling, punctuation, page and line
7 numbering, section numbering, and insertion of appro-
8 priate headings within the engrossment.
