Amendment offered by Rep. Andrea Salinas

Amendment description

The amendment would authorize various activities in connection with Civilian Conservation Centers, which are residential workforce development or training facilities for underserved youth that are operated by the Department of the Interior or the Department of Agriculture (USDA). The amendment requires USDA and Interior to offer at Civilian Conservation Centers specialized training programs focused on (1) forestry and rangeland management, (2) wildland firefighting, or (3) any other topic related to the mission of the Forest Service or Interior or the public interest. The Amendment authorizes USDA and Interior to directly hire qualified individuals who have successfully completed a Civilian Conservation Center training program without regard to certain civil service hiring requirements.

Additionally, the amendment requires USDA and Interior to establish a pilot program to expand available housing for wildland firefighters, volunteers, partner crew members, interns, and other agency employees. To carry out the program, USDA and Interior must employ individuals who are enrolled in a training program at a Civilian Conservation Center.
