OFFERED BY MR. THOMPSON OF PENNSYLVANIA

Page 19, line 15, insert “or the average of such sales over a set of consecutive calendar years that precedes the year in which such adverse event occurred, as determined by the Secretary,” after “occurred”.

Page 19, line 18, strike “appropriations” and insert “funds”.

Page 24, line 6, strike “and”.

Page 24, line 23, strike “3 years” and insert “2 years”.

Page 25, line 3, strike the period that appears after the close quotation marks and insert a semicolon.

Page 25, after line 3, insert the following:

- 1 (4) by redesignating subsection (e) as sub-

- 3 (5) by adding after subsection (d) the following:
- 4 “(e) REGULATION.—Any actions taken by the Sec-
- 5 retary under this section shall not be subject to review

- 7 any successor order.”.

9 the recipient of the assistance to meet perform-
10 ance goals;

11 (B) a description of any debt recovery
12 made with respect to a loan guaranteed under
13 this subsection, and agency projections for ac-
14 tivities for which the assistance is provided; and

15 (C) any recommendations of the Secretary
16 regarding the implementation of this sub-
17 section.
