## Vinsen Faris, CFRE

Vinsen serves as the Executive Director of Meals-on-Wheels of Johnson and Ellis Counties in North Central Texas. Under his leadership, the organization has grown from a small program serving a handful of people to a multi-county organization providing over 1,200 meals daily in a 1,700+ square mile service area.

Vinsen is recognized locally, statewide and nationally as an advocate for senior issues, especially senior hunger and isolation. He is known for his work in nonprofit management and board development, his fundraising expertise, and as a mentor for those working in the not-for-profit sector.

He is the Immediate Past Chair of the Board of Directors of Meals on Wheels America. During his two-year term as Chair, Vinsen helped lead the organization in "reimagining its future," revising its governance structure, and ultimately rebranding itself. He has provided testimony to the U.S. House of Representatives Committee on Ways and Means regarding the charitable giving tax deduction, appeared as a guest on both the "Diane Rehm Show" and MSNBC's "Hardball with Chris Matthews," and was featured in the ASAE magazine "Associations NOW" issue on volunteer leadership.

Vinsen first learned the importance of being a "people-person" just out of high school, while working at Six Flag over Texas. After a career in the food service / hospitality industry, he found his true calling in the work of community benefit organizations. He holds a Bachelor of Arts in Political Science and a Master of Public Administration from the University of Texas at Arlington.
