

Matthew Holmes became the CEO of the National Rural Water Association (NRWA) in 2020, after two decades with the organization. Matt began his career in Rural Water by helping small, rural, and tribal communities in New Mexico to modernize their utilities and provide safe water to their residents. He worked his way up from the grassroots into leadership at the state and national levels. He is accountable to a volunteer Board of

Directors representing 50 State Rural Water Associations and more than 30,000 drinking water and wastewater utility members nationwide.

Matt oversees programs that provide hands-on assistance to communities for regulatory compliance, operational troubleshooting, financial sustainability, workforce development, source water protection, energy efficiency, utility management, and board governance. These programs benefit over 80,000 water professionals annually in all 50 states, tribal nations, and U.S. territories.

He previously served as NRWA's Deputy CEO for six years and was responsible for operations and management. Matt led national disaster response efforts, coordinating field staff from State Associations around the country. In 2017, he was responsible for creating National Guideline Standards of Apprenticeship approved by the Department of Labor, resulting in dozens of registered apprenticeship programs benefiting the water workforce.

Matt has dedicated his career to helping rural and small communities meet water and environmental challenges. He holds an MA in Environmental and Natural Resource Economics from the University of New Mexico and a BS in Business Administration from the University of Arizona. Matt is an Eagle Scout and a lifelong outdoorsman. He holds certificates in avalanche rescue and rifle marksmanship. He grew up in Los Alamos, New Mexico.
