INTERIM SUBALLOCATION OF BUDGET ALLOCATIONS FOR FISCAL YEAR 2024

The Committee on Appropriations submits the following report on the interim suballocation of budget allocations for fiscal year 2024.

To facilitate the consideration of these bills by the House as soon as the opportunity arises, the Committee has provided interim 302(b) suballocations for the fiscal year 2024 Military Construction, Veterans Affairs, and Related Agencies Appropriations bill; the Legislative Branch Appropriations bill; the Agriculture, Rural Development, Food and Drug Administration, and Related Agencies Appropriations bill; and the Homeland Security Appropriations bill.

In developing these interim allocations, the Committee has been guided by the fiscal year 2024 discretionary spending limit included in the Limit, Save, Grow Act of 2023 (H.R. 2811), which was adopted by the House on April 26, 2023. By submitting this interim report and beginning its work on appropriations bills at this time, the Committee will be in the best possible position to report all fiscal year 2024 appropriations bills to the House under regular order.

The Committee notes that providing interim suballocations in this manner is not without precedent, particularly when the President's budget request is delayed as was the case this year. In those instances, the Committee reported an interim set of 302(b) suballocations for only some of the subcommittees and reported a full set of allocations thereafter. Similarly, when the House acts to adopt a concurrent resolution on the budget for fiscal year 2024 or

otherwise sets a discretionary topline, the Committee will distribute additional subcommittee allocations.

The interim suballocations in this report also incorporate potential adjustments to the Committee on Appropriations' 302(a) allocations for funding provided in reported bills for which the chair of the Committee on the Budget may make corresponding adjustments pursuant to legislation or resolution establishing fiscal year 2024 budget enforcement in the House of Representatives. Such adjustments will be made after eligible funding is included in a bill reported to the House and the chair of the Committee on the Budget subsequently adjusts the Committee on Appropriations' section 302(a) allocations.
