Inserts limitations and reporting requirements related to certain online speech-related activities. Inserts report language related to: directing funds under Nonproliferation, Anti-terrorism, Demining and Related Programs for countering drug cartels and transnational criminal organizations; and directing funds for training Department of State personnel on identifying and reporting victims of trafficking.
