## W. "RON" ALLEN, TRIBAL CHAIRMAN/CEO

As the Tribal Chairman, (serving 1977-present), Ron Allen is an elected leader whose responsibilities include protecting and advancing Tribal sovereignty and governmental authority and securing Tribal self-governance and self-reliance through active political engagement at the international, national, state and local levels of government. In these respective forums, Chairman Allen is a key advisor in helping to shape and address Administrative policy/regulatory decisions and Congressional legislation that supports Tribal Governmental authority and Treaty rights. As the Chief Executive Officer (CEO) (serving 1982-present), he is responsible for the executive administration of all the Tribe's programs and services, including, cultural and educational programs, career development and employment, social and community services, housing, health and wellness, economic development, natural resource management, and the Protection of Tribal Treaty Rights through cultural preservation and traditional affairs.

As Tribal Chairman/CEO, he is responsible for leading the Tribe from a zero-resource base in 1982 to a current annual budget level of over \$85 million; and from a landless reservation base in 1982 to a land base of over 2,000 acres without federal assistance. Additionally, he has grown the Tribal business portfolio through the establishment of several Tribal Enterprises, to include, Seven Cedars Resort Casino, The Cedars at Dungeness Golf Course, Northwest Native Expressions Art Gallery, Jamestown Cannabis Shop, Jamestown Family Health Clinic, Jamestown Family Dental Clinic, Jamestown Seafood, Inc., JKT Development Inc., Jamestown Excavating, Jamestown Networks, Longhouse Market and Deli; and Carlsborg Self Storage.

#### SIGNIFICANT ACTIVITIES AND ACCOMPLISHMENTS:

- Chairman of the DOI Self-Governance Advisory Committee formally sanctioned by the Assistant Secretary Indian Affairs (AS-IA) in 1998 to provide input on the implementation of the Title IV Amendments. The SGAC also serves as the liaison for Self-Governance Tribes providing advice to AS-IA on policy, legislative, budget and program discussion and decision-making actions which affect over 260 Self-Governance Tribes.
- Vice Chairman of the Indian Health Service Tribal Self-Governance Advisory Committee (formed in 1996)
  which provides advice to the IHS Director on Self-Governance policy, legislative, budget and program
  discussion and decision-making actions affecting over 337 Tribes.
- Chairman of the Tribal Legislative Drafting Committee to develop Self-Governance legislation within both the Department of Interior (resulting in Public Law 103-413 in 1994) and the Department of Health and Human Services (resulting in Public Law 106-260 in 2000).
- Chairman of the Self-Governance Communication and Education Tribal Consortium. This Consortium is the lead non-profit organization which provides education and communication services regarding the Self-Governance initiative ensuring that accurate information is provided to Congress, Administration, the federal government, tribal governments and the general public.
- Tribal Co-Chair/Northwest Tribal Representative on the Bureau of Indian Affairs/Tribal Interior Council since 1992. This Council works with the Administration and Congress in developing Tribal budget priorities. This Council provides an advisory Government-to-Government forum and process for Tribes and the Department to develop budgets that allow for the fulfillment of tribes' self-determination, self-governance, sovereignty, and treaty rights, as well as, sufficient levels of funding to address the needs of Tribes and their tribal citizens.
- Chairman of the Department of Interior Bureau of Indian Affairs/Tribal Interior Budget Council Data Management Subcommittee created as a partnership between Tribal and Federal Representatives to assess statutory and regulatory performance data reporting requirements and determine other program data collection needs. This assessment will consider issues related to GPRA and PART and Tribally-driven data collection needs. The DMC has been tasked with advising the TIBC on strategies and data collection processes and systems to justify budget increases to meet unmet needs and fully fund budget priorities, support budget formulation, fund distribution, program management, and statutory and regulatory reporting requirements.
- Served as Chairman of the National Congress of American Indians National Policy Workgroup on Contract Support Costs and Co-Chairman to of the 1987 publication entitled "Determining the True Cost of Contracting Federal Programs for Indian Tribes." These Workgroups have developed an analysis of indirect cost recovery for Indian Tribes and have been responsible for working with the Administration and Congress on developing short and long-term recommendations on these related issues.
- Served as Chairman of an Ad-hoc team of Tribal leaders to design & develop the 1989 Centennial Accord between the 26 Tribes in Washington State. Participated in the Annual State/Tribe Summit in November 1999 to develop a Millennium Agreement to institutionalize effective government-to-government relationships in Washington State. There are currently 29 Tribes participating in this Accord.
- Served as Co-Chairman of the National Congress of American Indians/National Council of State Legislators Advisory Committee since 1998. This Committee has worked to advance state-tribal governmental relations including the publication of various policy and educational documents
- Chaired numerous national workgroup committees and task forces for trust, contract support, etc.
