I continue to provide advice and assistance to tribal members and non-tribal members as to the process of Tribal, Federal, State and Local governments and laws and the grantee plan, based upon current regulations and policies to our local families. I am extremely familiar with local tribal personnel, locations and cultural beliefs, as well as other federal agencies to fully benefit personal relations.
