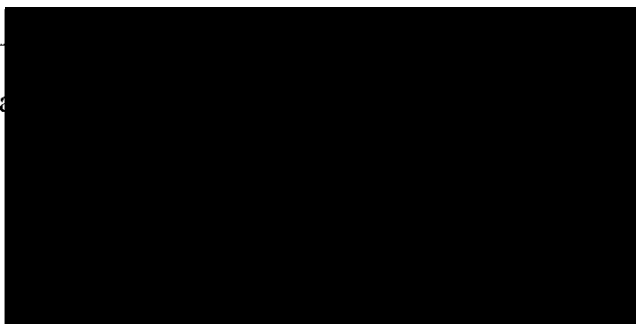


## Witness Disclosure Form
