All grants listed below were made to Defenders of Wildlife.

Department of the Interior

U.S. Fish and Wildlife Service:

-July 2013: \$36,000 to support electric fencing and technical expertise for landowners living in the Yaak to Yahk project area. (Pass-through from the National Fish and Wildlife Foundation.)

-June 2013: \$4,800 to work with the Fort Belknap Fish and Wildlife agency on a comprehensive wildlife management plan and to restore black-footed ferrets on the Fort Belknap Indian Reservation. This grant was amended on June 7, 2014 for an additional \$7,200, bringing the total grant amount to \$12,000. (Pass-through via World Wildlife Fund and National Fish and Wildlife Foundation.)

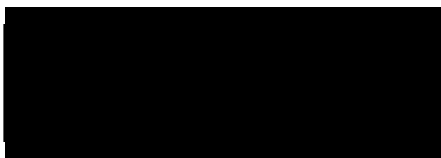
-May 2014: \$5,000 to help with coordination of the Northern Plains Conservation Network, a group of 80 individuals and 25 organizations working together to conserve the wildlife and habitat of the northern plains. (Pass-through via World Wildlife Fund and National Fish and Wildlife Foundation.)

Department of Agriculture

U.S. Forest Service

-June 2014: \$9,500 to purchase bear-resistant garbage carts in the Seeley Lake, Montana area to prevent/reduce human-bear conflict. This grant was made by the Missoula County Resource Advisory Committee (RAC), a FACA-approved advisory committee to the Lolo National Forest.
