Develops and maintains on-going communication between the CRIHB organization, the Indian Health Service, tribes and other governmental agencies and tribal governments. Prepares written analyses of Indian Health-related policies, legislation and regulations, for use by CRIHB staff and for distribution to the Tribal Governments and CRIHB member programs. Provides input to planning and facilitating quarterly Board of Director meetings, Tribal Government Consultation Committee meetings and Tribal Health Care Leaders Legislative Visits on Capitol Hill and in the California Legislature. 12/03-9/13
