## Mark Wolfe

Mark Wolfe is an energy economist who is a leading expert on developing grant and finance initiatives for low and moderate income households. He has extensive experience working with state energy, human services and housing agencies to develop, manage and integrate grant and finance resources for addressing energy and housing affordability concerns. He works across government sectors focusing on low and moderate income families in underserved communities and energy affordability issues. He is a sought-after speaker in those areas.

As Executive Director of the National Energy Assistance Directors Association (NEADA) and the Energy Programs Consortium (EPC), Mark is responsible for representing the interests of state low income energy directors before Congress. This year he has been instrumental in working with congressional committees to develop appropriation levels for the Low Income Home Energy Assistance Program (LIHEAP) which address the impact of pandemic-related job loss. He is also leading a national media campaign to support increased funding for energy assistance to help stabilize low income families as well as managing targeted research projects.

His previous experience includes serving as the policy director for the Coalition of Northeastern Governors; policy advisor for the US Treasury Department; editor of the State and Local Energy Report; program director for the National Governors Association; and a senior analyst for the Congressional Research Service.
