In 2022, the National Alliance for Public Charter Schools (the National Alliance) received a Charter Schools Program (CSP) National Dissemination Grant for \$2,101,385 over a three year grant period to study the charter school response to the COVID-19 pandemic and disseminate best practices.

The National Alliance previously received a CSP National Dissemination Grant in 2018 for \$2,358,960 over three years to establish a Charter School Facility Center.

In 2022, the National Alliance received \$250,000 for the Rural Community Development Initiative from the United State Department of Agriculture (USDA), to help rural locations to build capacity to do strategic planning for community facilities.

In 2023, the National Alliance received \$150,000 for Community Facilities Technical Assistance and Training from the USDA, to help rural communities to go through the process of financing rural facilities.
