At the appropriate place in subtitle D of title XVI,  
insert the following new section:

1 **SEC. 16** \_\_\_\_\_. **CERTIFICATION ON NUCLEAR FORCE STRUC-**  
2 **TURE.**

3 Not later than 90 days after the date of the enact-  
4 ment of this Act, the Chairman of the Joint Chiefs of  
5 Staff, in coordination with the Commander of the United  
6 States Strategic Command, shall certify to the congress-  
7 sional defense committees that the plan for implementa-  
8 tion of the New START Treaty (as defined in section  
9 494(a)(2)(D) of title 10, United States Code) announced  
10 on April 8, 2014, will enable the United States to meet  
11 its obligations under such treaty in a manner that ensures  
12 the nuclear forces of the United States—

- 13 (1) are capable, survivable, and balanced; and
- 14 (2) maintain strategic stability, deterrence and  
15 extended deterrence, and allied assurance.

At the appropriate place in subtitle B of title XXXI,  
insert the following:

1 **SEC. 31 \_\_\_\_ . ANALYSIS OF EXISTING FACILITIES.**

2 (a) REPORT.—Not later than 270 days after the date  
3 of the enactment of this Act, the Administrator for Nu-  
4 clear Security shall submit to the congressional defense  
5 committees a report containing an analysis of using or  
6 modifying existing facilities across the nuclear security en-  
7 terprise (as defined in section 4002 of the Atomic Energy  
8 Defense Act (50 U.S.C. 2501)) to support the plutonium  
9 strategy of the National Nuclear Security Administration.

10 (b) MATTERS INCLUDED.—The report under sub-  
11 section (a) shall include the following:

12 (1) An analysis of the costs, benefits, cost-sav-  
13 ings, risks, and effects of using or modifying existing  
14 facilities of the nuclear security enterprise as com-  
15 pared to the current plan of the Administrator for  
16 supporting the plutonium strategy of the Adminis-  
17 tration, including all phases of the plan.
