| 10 | "(a) Quarterly Installments.—In carrying out               |
| 11 | activities under the Program in the People's Republic of   |
| 12 | China, the Secretary of Defense shall ensure that Cooper-  |
| 13 | ative Threat Reduction funds for such activities are obli- |
| 14 | gated or expended in quarterly installments.               |
| 15 | "(b) Quarterly Certifications.—                            |
| 16 | "(1) Limitation.—The Secretary of Defense                  |
| 17 | may not obligate or expend any Cooperative Threat          |
| 18 | Reduction funds for activities in the People's Repub-      |
| 19 | lie of China during a quarter unless the Secretary         |

| 7  | Secretary shall submit to the committees specified in |
| 8  | paragraph (1) a certification, made in concurrence    |
| 9  | with the Secretary of State, of the following:        |
| 10 | "(A) China has taken material steps to—               |
| 11 | "(i) disrupt the proliferation activities             |
| 12 | of Li Fangwei (also known as Karl Lee, or             |
| 13 | any other alias known by the United                   |
| 14 | States); and  |
| 15 | "(ii) arrest Li Fangwei pursuant the                  |
| 16 | indictment charged in the United States               |
| 17 | District Court for the Southern District of           |
| 18 | New York on April 29, 2014.                           |
| 19 | "(B) China has not proliferated to any                |
| 20 | non-nuclear weapons state, or any nuclear             |
| 21 | weapons state in violation of the Treaty on the       |
| 22 | Non-Proliferation of Nuclear Weapons, any             |
| 23 | item that contributes to a ballistic missile or       |
| 24 | nuclear weapons delivery system.                      |
