

National Defense Authorization Act for Fiscal Year 2017

At the appropriate place in title V, add the following new section:

6	(a) REVISION REQUIRED.—Section 1551 of title 10,
7	United States Code, is amended—
8	(1) by inserting "(a) Service Under As-
9	SUMED NAME.—" before "The Secretary"; and
10	(2) by adding at the end the following new sub-
11	section:
12	"(b) Effect of Change in Name.—The Secretary
13	of the military department concerned shall reissue a cer-
14	tificate of discharge or an order of acceptance of resigna-
15	tion in the new name of any person who, after separation
16	from an armed force under the jurisdiction of that Sec-
17	retary, legally changes the person's name to reflect the
18	person's gender identity.".

Amendment to H.R. 4909 National Defense Authorization Act for Fiscal Year 2017

Offered by Congressman Ruben Gallego

In the appropriate place in the report to accompany H.R. 4909, insert the following new Directive Report Language:

Informing service members about the United Services Military Apprenticeship Program

The committee directs the Secretary of the Navy to ensure that all enlisted Sailors and Marines receive a briefing during their military occupational specialty training that provides an overview of the United Services Military Apprenticeship Program (USMAP), including how to register and navigate USMAP and the value of USMAP in obtaining civilian employment following military service. The Secretary of the Navy is also encouraged to ensure that USMAP coordinators are assigned to appropriate commands. The committee directs the Secretary of the Navy to provide a briefing to the House Committee on Armed Forces by April 1, 2017, on the updated policy implementation plan for USMAP.

AMENDMENT TO H.R. 4909

OFFERED BY MR. MOULTON OF MASSACHUSETTS

At the appropriate place in title VII, add the following new section:

1	SEC. 7 MENTAL HEALTH RESOURCES FOR MEMBERS
2	OF THE MILITARY SERVICES AT HIGH RISK
3	OF SUICIDE.
4	(a) In General.—The Secretary of Defense shall
5	develop a methodology that identifies which members of
6	the military services are at high risk of suicide.
7	(b) MENTAL HEALTH RESOURCES.—
8	(1) High risk members of the military
9	SERVICES.—The Secretary of Defense shall use the
10	results under subsection (c) to—
11	(A) identify which units have a dispropor-
12	tionately high rate of suicide and suicide at-
13	tempts; and
14	(B) provide additional preventative and
15	treatment resources for mental health for mem-
16	bers of the military services who were deployed
17	with the units identified under subparagraph
18	(A).

1	(2) Preventative mental health care.—
2	The Secretary of Defense shall use the results under
3	subsection (c) to—
4	(A) identify the circumstances of deploy-
5	ments associated with increased vulnerability to
6	suicide, including the length of deployment, the
7	region and area of deployment, and the nature
8	and extent to which there was contact with
9	enemy forces; and
10	(B) provide additional preventative mental
11	health care to units who currently are, or will
12	be, deployed under circumstances similar to
13	those of subparagraph (A).
14	(c) Methodology.—Not later than 180 days after
15	the date of the enactment of this Act, the Secretary of
16	Defense shall develop a methodology to assess the rate of
17	suicide and suicide attempts of members of the military
18	services of units that have been deployed in support of
19	a contingency operation after September 11, 2001.
20	(d) Reports.—Not later than September 30, 2017,
21	the Secretary of Defense shall submit to the Committee
22	on Armed Services of the House of Representatives and
23	the Committee on Armed Services of the Senate a report
24	on the activities carried out under this section and the
25	effectiveness of such activities

- 1 (e) RESTRICTION ON USE OF INFORMATION.—Infor-
- 2 mation disclosed or obtained pursuant to the provisions
- 3 of this section may be used by officers, employees, and
- 4 contractors of the Department of Defense only for the

AMENDMENT TO H.R. 4909 OFFERED BY MR. LOBIONDO OF NEW JERSEY

At the appropriate place in title II, insert the following:

1	SEC. 2 PILOT PROGRAM ON ADVANCED TECHNOLOGY
2	FOR ALCOHOL ABUSE PREVENTION.
3	(a) In General.—Not later than 90 days after the
4	date of the enactment of this Act, the Secretary of De-
5	fense, in consultation with the Secretaries of the military
6	departments, shall establish a pilot program to dem-
7	onstrate the feasibility of using portable, disposable alco-
8	hol breathalyzers and a cloud based server platform to col-
9	lect data and monitor the progress of alcohol abuse pre-
10	vention programs through the use of digital applications.
11	(b) Elements.—In carrying out the pilot program
12	under subsection (a), the Secretary shall—
13	(1) select at least three locations at which to
14	carry out the program, including at least one mili-
15	tary service initial training location;
16	(2) at each location selected under paragraph
17	(1), include at least one active duty unit with no less
18	than 300 personnel and one reserve unit with no less
19	than 300 personnel; and

1	(3) offer participation in the pilot program on
2	a voluntary basis.
3	(e) Duration.—The pilot program under subsection
4	(a) shall be operational for a minimum of 6 months and
5	shall terminate not later than September 30, 2018.
6	(d) REPORTS REQUIRED.—The Secretary of Defense
7	shall submit to the Committees on Armed Services of the
8	Senate and the House of Representatives—
9	(1) not later than 120 days after the date of
10	the implementation of the pilot program under sub-
11	section (a), a report on the implementation of the
12	program; and
13	(2) not later than one year after the date of the
4	implementation of the program, a report on the pro-
15	gram, including findings and recommendations of
16	the Secretary with respect to the benefits of using
17	advanced technology as part of alcohol abuse preven-
18	tion efforts within the military services.
19	(e) Funding.—The Secretary of Defense may carry
20	out the pilot program under subsection (a) using amounts
21	authorized to be appropriated for Alcohol Abuse Preven-
22	tion Programs as specified in the funding tables in division
23	D.

In section 4301 of division D, relating to operation & maintenance, Defense-wide, insert under the matter re-

lating to the Office of the Secretary of Defense, Line 300, a new item "Alcohol Abuse Prevention Programs" at \$1,000,000.

In section 4701 of division D, relating to Department of Energy national security programs, research, development, test, and evaluation, under the matter relating to advanced manufacturing, reduce the amount for component manufacturing development by \$1,000,000.

Amendment to H.R. 4909 National Defense Authorization Act for Fiscal Year 2017

In the appropriate place in the report to accompany H.R. 4909, insert the following new Directive Report Language:

NATIONAL GUARD BUREAU BRIEFING REQUIREMENT

The Committee notes a perceived imbalance regarding manning and resource allocation on a State by State and territory by territory basis, therefore the National Guard Bureau is directed to provide a report to the Committee on Armed Services of the House of Representatives on the distribution of full-time manning and controlled grade positions as they relate to all 54 states and territories no later than February 1, 2017, that includes the following elements:

- 1) A description of the National Guard Bureau formula and allocation of fulltime manning and how that number relates to resource end strength; why states are currently equally funded at the headquarters, staff and senior controlled grade level.
- 2) Analysis and recommendations of a manning and end strength formula based upon an equitable formula as opposed to equally divided among states and territories, to include why states are not resourced at the paid end strength levels with full-time manning when requested to increase end strength by National Guard Bureau.

At the end of subtitle C of title V, add the following new section:

9	"(a) Leave Authorized.—A member of the armed

15	shall be at least 14 days, under regulations prescribed
16	under this section by the Secretary concerned.
17	"(e) Duration of Availability of Leave.—Leave
18	under this section is lost as follows:

1	"(1) If not used within one year of the date of
2	the birth giving rise to the leave.
3	"(2) If the member having the leave becomes
4	entitled to leave under this section with respect to a
5	different child.
6	"(3) If not used before separation from active
7	service.
8	"(d) Coordination With Other Leave Authori-
9	TIES.—Leave under this section is in addition to any other
10	leave and may not be deducted or charged against other
11	leave authorized by this chapter.
12	"(e) Regulations.—This section shall be carried
13	out under regulations prescribed by the Secretary con-
14	cerned. Regulations prescribed under this section by the
15	Secretaries of the military departments shall be as uni-
16	form as practicable and shall be subject to approval by
17	the Secretary of Defense.".

Amendment to H.R. 4909 National Defense Authorization Act for Fiscal Year 2017

Offered by: Mr. Peters of California

In the appropriate place in the report to accompany H.R. 4909, insert the following new Directive Report Language:

Network of Support

The committee commends that Department of Defense's (DoD) efforts to inform military fami9lies of the aspects and stressors of daily military life experienced by members of the armed forces, as well as the services available to assist service members with those stressors.

However, the committee believes that the military services can improve upon current efforts by providing information over the duration of the military service and during the transition to civilian life, when appropriate, coordinating across all branches the information that is provided, and how it is disseminated, and providing servicemembers the opportunity to submit their "network of support" to receive this important information.

Therefore, the committee directs the Secretary of Defense to assess the options for new recruits of the armed forces to identify a small number of people that encompass their network of support and to identify the best ways to integrate these contacts into existing outreach efforts, including the estimated cost associated with this effort. In addition, the Secretary shall brief the Committee of Armed Services of the House of Representatives not later than February 1, 2017 on the results of the assessment.

Amendment to H.R. 4909 National Defense Authorization Act for Fiscal Year 2017

In the appropriate place in the report to accompany H.R. 4909, insert the following new Directive Report Language:

Community and Military Education Partnerships

The Committee is aware that partnerships exist between the military and civilian communities to enhance education support of all children by understanding the needs and perspective of military children.

Therefore, the Committee directs Secretary of Defense to provide a briefing to the House Armed Services Committee not later than March 1, 2017, on the policies governing ongoing partnership efforts between the Department and communities with unusually high concentrations of military dependents enrolled in public schools. The briefing should address the following elements:

- (1) An evaluation of partnership efforts in areas considered overseas assignments with unusually high concentrations of military dependents enrolled;
- (2) Organizations and resources currently dedicated to enhancement of these community partnerships;
- (3) Policies and guidelines governing the funding community partnerships;
- (4) Any other maters the Secretary deems relevant.
