

## AMENDMENT TO H.R. 5515 OFFERED BY MR. DESJARLAIS OF TENNESSEE

At the end of subtitle D of title XII, add the following new section:

1	SEC. 12 LIMITATION ON AVAILABILITY OF FUNDS TO EX-
2	TEND THE IMPLEMENTATION OF THE NEW
3	START TREATY.
4	(a) FINDINGS.—Congress finds the following:
5	(1) The New START Treaty provides that,
6	"[w]hen a Party believes that a new kind of stra-
7	tegic offensive arm is emerging, that Party shall
8	have the right to raise the question of such a stra-
9	tegic offensive arm for consideration in the Bilateral
10	Consultative Commission".
11	(2) Russian Federation President Vladimir
12	Putin stated in a March 1, 2018, public speech
13	that—
14	(A) "I will speak about the newest systems
15	of Russian strategic weapons that we are cre-
16	atingwe have embarked on the development
17	of the next generation of missiles.":

1	(B) "We started to develop new types of
2	strategic arms that do not use ballistic trajec-
3	tories at all when moving toward a target.";
4	(C) "One of them is a small-scale heavy-
5	duty nuclear energy unit that can be installed
6	in a missile like our latest X-101 air-launched
7	missileIn late 2017, Russia successfully
8	launched its latest nuclear-powered missile at
9	the central training ground. During its flight,
10	the nuclear-powered engine reached its design
11	capacity and provided the necessary propul-
12	sion.";
13	(D) "[i]n December 2017, an innovative
14	nuclear power unit for this unmanned under-
15	water vehicle completed a test cycle that lasted
16	many years[t]he tests that were conducted
17	enabled us to begin developing a new type of
18	strategic weapon that would carry massive nu-
19	clear ordnance";
20	(E) "[b]y the way, we have yet to choose
21	names for these two new strategic weapons, the
22	global range cruise missile and the unmanned
23	underwater vehicle. We are waiting for sugges-
24	tions from the Defence Ministry';

1	(F) "A real technological breakthrough is
2	the development of a strategic missile system
3	with fundamentally new combat equipment- a
4	gliding wing unit, which has also been success-
5	fully tested[w]e called it the Avangard";
6	and
7	(G) "I want to specifically emphasise that
8	the newly developed strategic arms - in fact,
9	new types of strategic weapons- are not the re-
10	sult of something left over from the Soviet
11	Union. Of course, we relied on some ideas from
12	our ingenious predecessors. But everything I
13	have described today is the result of the last
14	several years, the product of dozens of research
15	organisations, design bureaus and institute.".
16	(3) During the House Armed Services Com-
17	mittee hearing on April 12, 2018, Secretary of De-
18	fense James Mattis was asked whether Russia
19	should honor the terms of the treaty and limit its
20	new strategic offensive arms under the New START
21	Treaty as it requires and he stated "Sir, I believe
22	they should.".
23	(b) LIMITATION.—None of the funds authorized to
24	be appropriated or otherwise made available for fiscal year
25	2019 for the Department of Defense may be obligated or

1	expended to extend the implementation of the New
2	START Treaty unless and until the President—
3	(1) certifies to the appropriate congressional
4	committees that—
5	(A) the President has raised the issue of
6	covered Russian systems in the appropriate fora
7	with the Russian Federation under Article V of
8	the New START Treaty or otherwise; and
9	(B) the Russian Federation has responded
10	in writing to the United States as to whether
11	they will agree to declare the covered Russian
12	systems as strategic offensive arms or otherwise
13	pursuant to the New START Treaty;
14	(2) submits a copy of the written response of
15	the Russian Federation described in paragraph
16	(1)(B) to the appropriate congressional committees;
17	and
18	(3) notifies the appropriate congressional com-
19	mittees as to whether the position of the Russian
20	Federation threatens the viability of the New
21	START Treaty or requires appropriate United
22	States political, economic, or military responses.
23	(c) Definitions.—In this section:

1	(1) APPROPRIATE CONGRESSIONAL COMMIT-
2	TEES.—The term "appropriate congressional com-
3	mittees" means—
4	(A) the congressional defense committees;
5	and
6	(B) the Committee on Foreign Relations of
7	the Senate and the Committee on Foreign Af-
8	fairs of the House of Representatives.
9	(2) COVERED RUSSIAN SYSTEMS.—The term
10	"covered Russian systems" means the following:
11	(A) The heavy intercontinental missile sys-
12	tem known as "Sarmat" or otherwise identified.
13	(B) An air-launched nuclear-powered
14	cruise missile known as "X-101" or otherwise
15	identified.
16	(C) An unmanned underwater vehicle
17	known as "Status 6" or otherwise identified.
18	(D) The long-distance guided flight
19	hypersonic weapons system known by
20	"Avanguard" or otherwise identified.
21	(3) NEW START TREATY.—The term "New 5
22	START Treaty' means the Treaty between the
23	United States of America and the Russian Federa-
24	tion on Measures for the Further Reduction and
25	Limitation of Strategic Offensive Arms, signed at
