## AMENDMENT TO H.R. 4350 OFFERED BY MR. BACON OF NEBRASKA

At the appropriate place in title X, insert the following:

1	SEC. 10 REPORT AND BRIEFING ON UNITED STATES
2	EQUIPMENT, PROPERTY, AND CLASSIFIED
3	MATERIAL THAT WAS DESTROYED, SURREN-
4	DERED, AND ABANDONED IN THE WITH-
5	DRAWAL FROM AFGHANISTAN.
6	(a) In General.—Not later than 180 days after the
7	date of the enactment of this Act, the Secretary of De-
8	fense, in consultation with the Secretaries of the military
9	departments and the Commander of United States Central
10	Command, shall submit to the congressional defense com-
11	mittees a report regarding the covered United States
12	equipment, property, and classified material that was de-
13	stroyed, surrendered, or abandoned in Afghanistan during
14	the covered period. Such report shall include each of the
15	following:
16	(1) A determination of the value of the covered
17	United States equipment, property, and classified
18	material that was destroyed, surrendered, or aban-

1	doned, disaggregated by military department and
2	itemized to the most specific feasible level.
3	(2) An itemized list of destroyed, surrendered
4	or abandoned aircraft, aircraft parts and supply
5	and aircraft maintenance items, including aircraft
6	aircraft parts and supply, and aircraft maintenance
7	items formerly possessed by the Afghan Air Force or
8	the former government of Afghanistan.
9	(3) An itemized list of destroyed, surrendered
10	or abandoned fuel and fuel dispensing equipment
11	disaggregated by military department.
12	(4) An itemized list of destroyed, surrendered
13	or abandoned weapons, weapon systems, components
14	of weapons or weapon systems, ammunition, explo-
15	sives, missiles, ordnance, bombs, mines, or projec-
16	tiles, disaggregated by military department.
17	(5) For each item on a list referred to in para-
18	graphs (2) through (4), an explanation of the legal
19	authority relied upon to destroy, surrender, or aban-
20	don that specific item.
21	(6) An evaluation of the capabilities of the
22	Taliban post-withdrawal as a result of their seizure
23	of surrendered or abandoned covered United States
24	equipment, property, and classified material.

1	(7) An assessment of the damage to the na-
2	tional security interests of the United States as a re-
3	sult of the destroyed, surrendered, or abandoned
4	covered United States equipment, property, and
5	classified material.
6	(8) An assessment of the feasibility of disabling,
7	destroying, or recapturing surrendered or abandoned
8	covered United States equipment, property, or clas-
9	sified material.
10	(9) Available imagery or photography depicting
11	the Taliban possessing surrendered or abandoned
12	covered United States equipment, property, or clas-
13	sified material.
14	(b) Executive Summary of Report.—The report
15	required under subsection (a) shall include an executive
16	summary of the report, which shall be unclassified and
17	made publicly available.
18	(c) Briefing.—Not later than 200 days after the
19	date of the enactment of this Act, the Secretary of De-
20	fense, the Secretaries of the military departments, and the
21	Commander of United States Central Command shall pro-
22	vide to the congressional defense committees a briefing on
23	the report required by this section.
24	(d) Definitions.—In this section:

1	(1) The term "covered United States equip-
2	ment, property, and classified material" means any
3	of the following items formerly owned by the Gov-
4	ernment of the United States or provided by the
5	United States to the former government or military
6	of Afghanistan during the covered period:
7	(A) Real property, including any lands
8	buildings, structures, utilities systems, improve-
9	ments, and appurtenances, thereto, including
10	equipment attached to and made part of build-
11	ings and structures, but not movable equip-
12	ment.
13	(B) Personal property, including property
14	of any kind or any interest therein, except real
15	property.
16	(C) Equipment, including all nonexpend-
17	able items needed to outfit or equip an indi-
18	vidual or organization.
19	(D) Classified information, in any form, in-
20	cluding official information that has been deter-
21	mined to require, in the interests of national se-
22	curity, protection against unauthorized disclo-
23	sure and which has been so designated.
24	(2) The term "covered period" means the pe-
25	riod beginning on February 29, 2020, and ending on
