or former cadet refused to receive a vaccination against

3 (d) RETROACTIVE APPLICABILITY.—The amendments made by this section shall have retroactive effect 4 5 and apply to a cadet or midshipman at a military service academy who, on or after January 1, 2020, was not ten-6 7 dered an appointment as a commissioned officer in the 8 Armed Forces on the sole basis that such cadet or midshipman refused to receive a vaccination against COVID-9 19. 10
