9 "(6) except as provided in paragraph (7), notify 10 parents of any medical examinations or screenings 11 the school may administer to their child and receive 12 written consent from parents for any such examina-13 tion or screening prior to conducting the examina-14 tion or screening;

15 "(7) in the event of an emergency that requires 16 a medical examination or screening without time for 17 parental notification, promptly notify parents of 18 such examination or screening and, not later than 19 24 hours after the incident occurs, provide an expla-12 nation of the emergency that prevented notification 21 prior to such examination or screening;

"(8) notify parents of any medical information
that will be collected on their child, receive written
parental consent prior to collecting such information,

and provide parents an opportunity to inspect such
 information at the parent's request; and

3 "(9) notify parents of any policy changes involv4 ing their reporting obligations under the Family Ad5 vocacy Program of the Department of Defense.

6 "(c) SCHOOL ADVISORY Committees AND 7 BOARDS.—Not less frequently than four times per year. 8 a school advisory committee or school board for a school 9 operated by the Department of Defense Education Activity shall provide parents of children attending the school 10 11 with the opportunity to address the advisory committee 12 or school board on any matters relating to the school or the educational services provided to their children. 13

14 "(d) DEFINITION.—In this section, the term 'school
15 operated by the Department of Defense Education Activ16 ity' means—

17 "(1) a Department of Defense domestic depend18 ent elementary or secondary school, as described in
19 section 2164 of this title; or

20 "(2) any elementary or secondary school or pro21 gram for dependents operated by the Department of
22 Defense Education Activity.".
